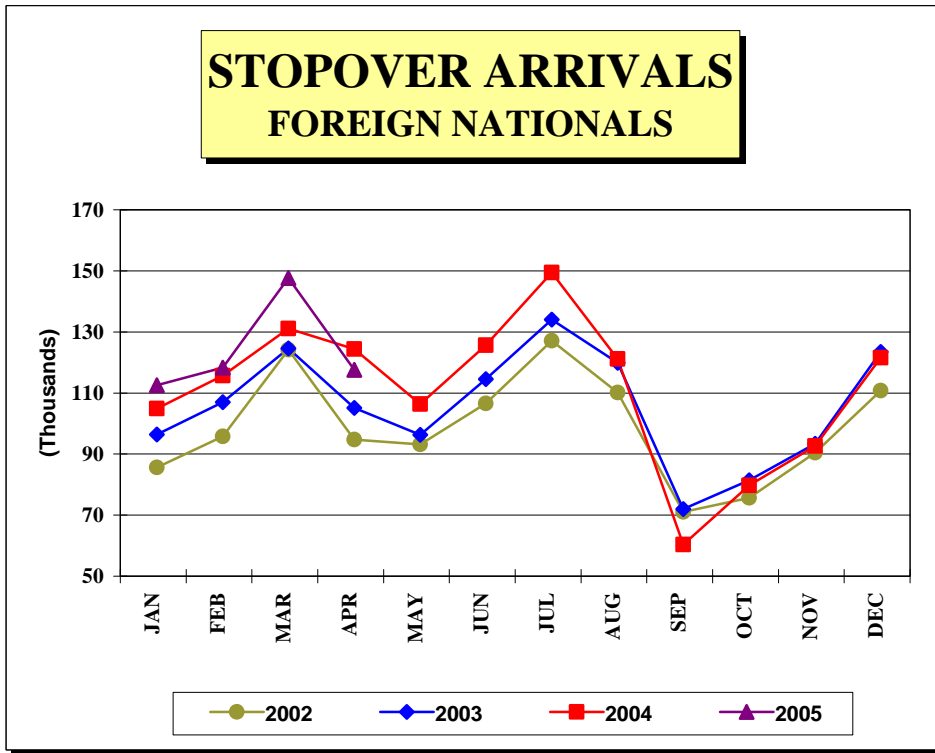

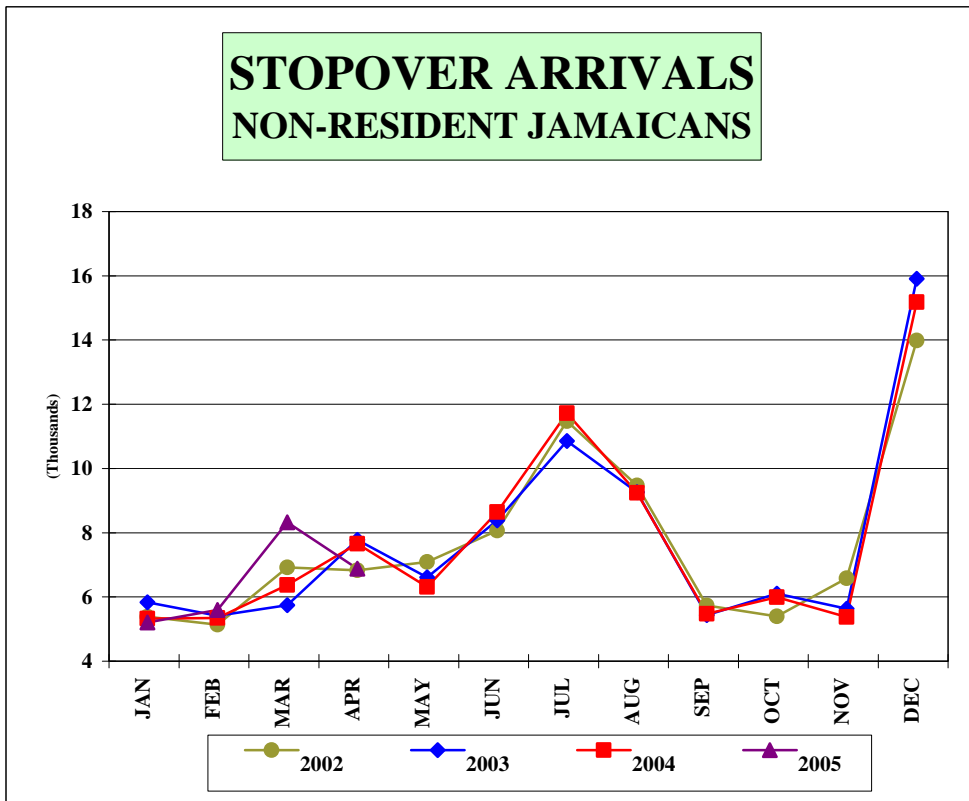

JANUARY - APRIL 2005**

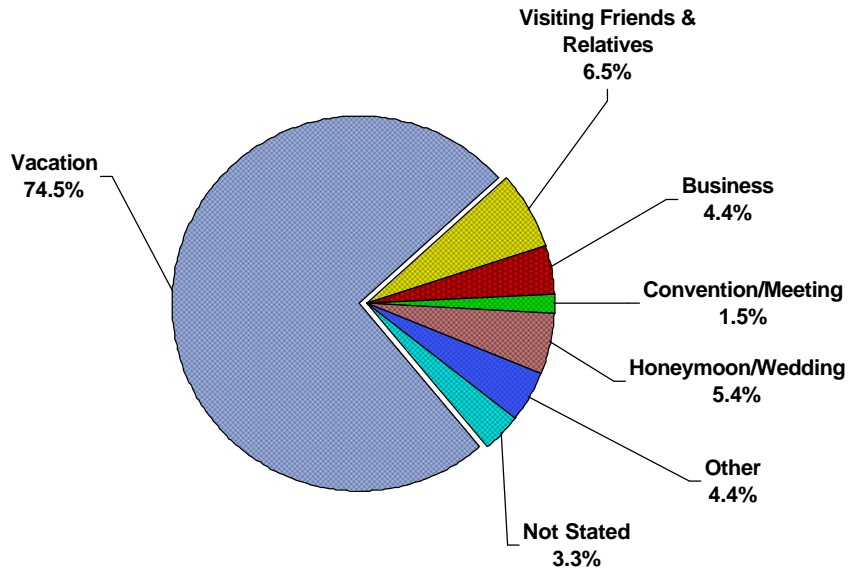

STOPOVER VISITORS BY MARKET SHARE

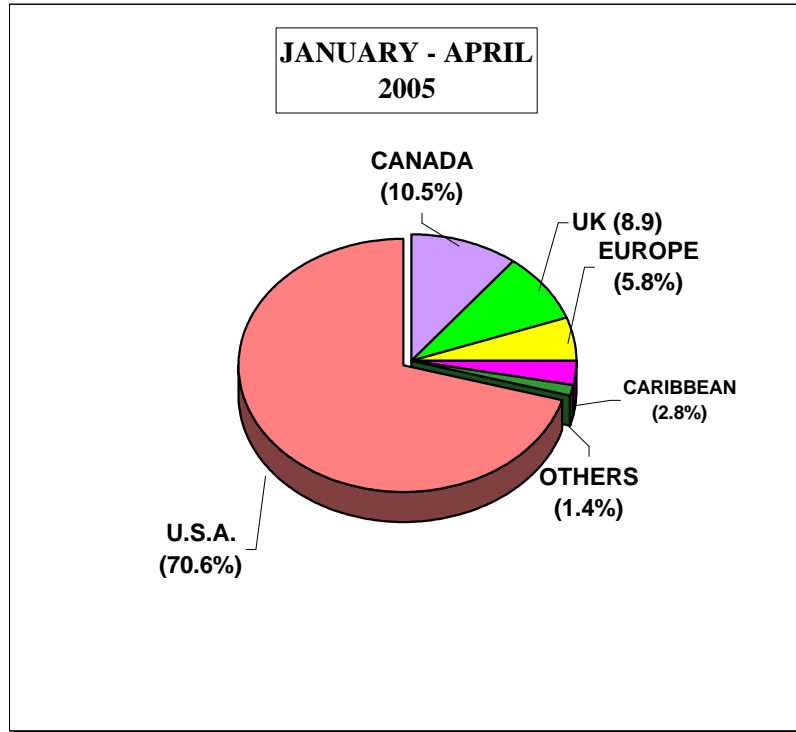

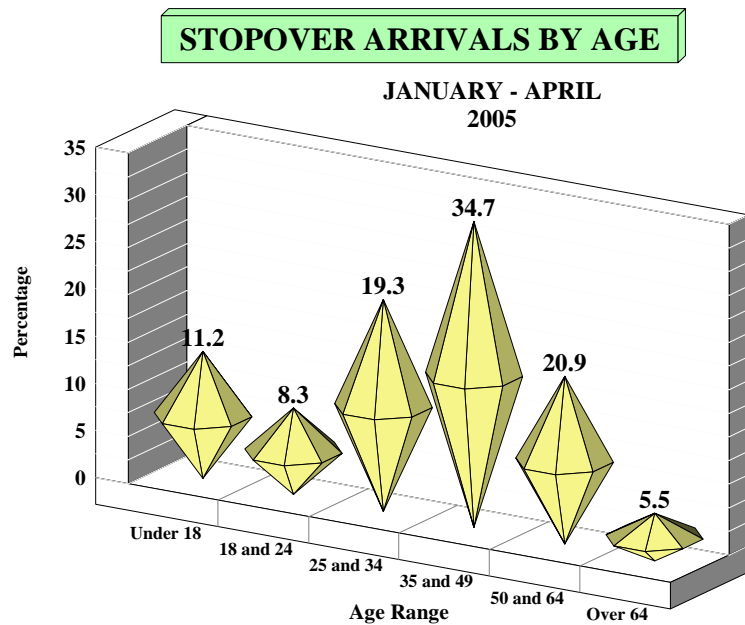

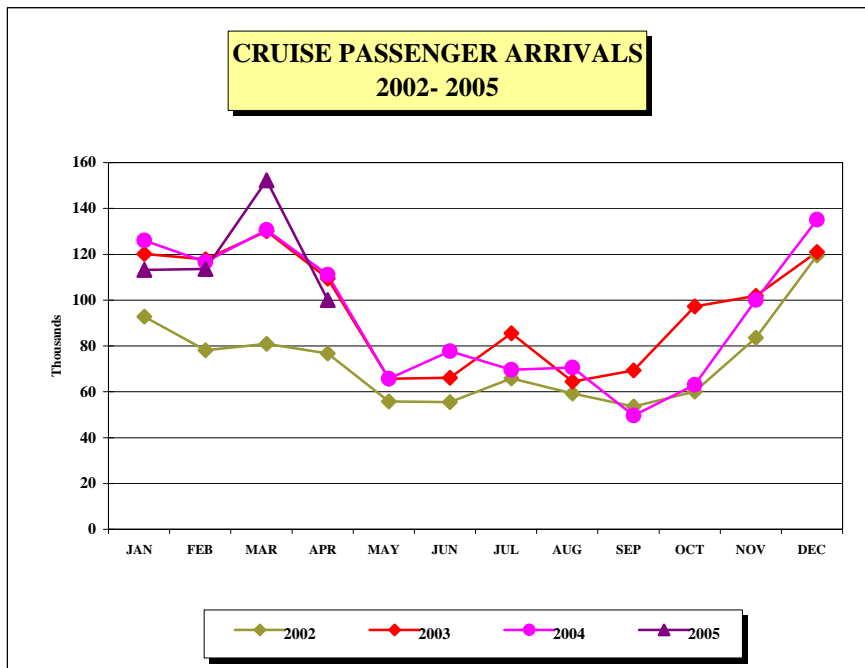

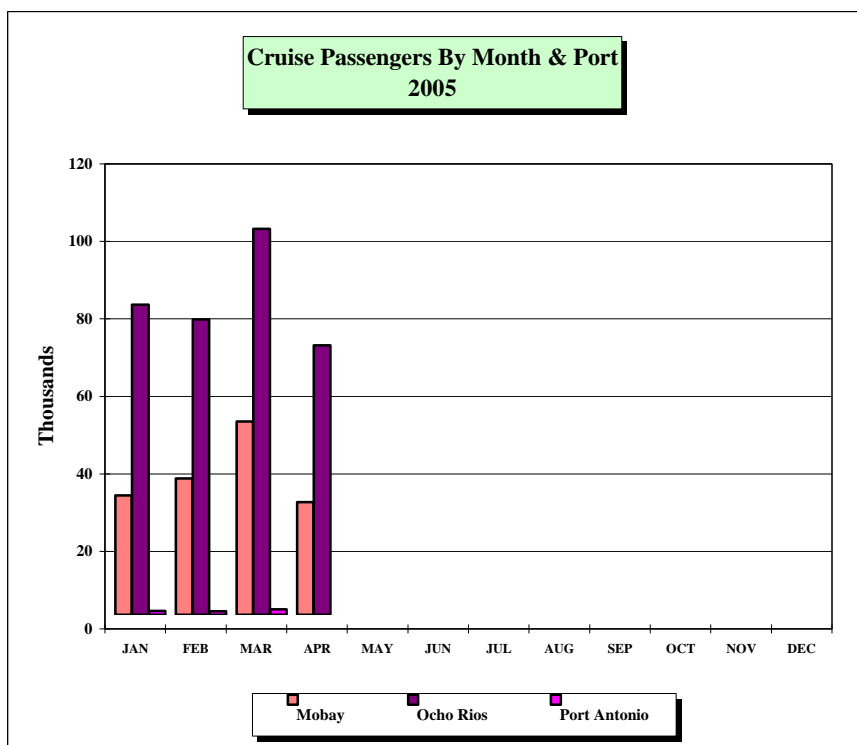

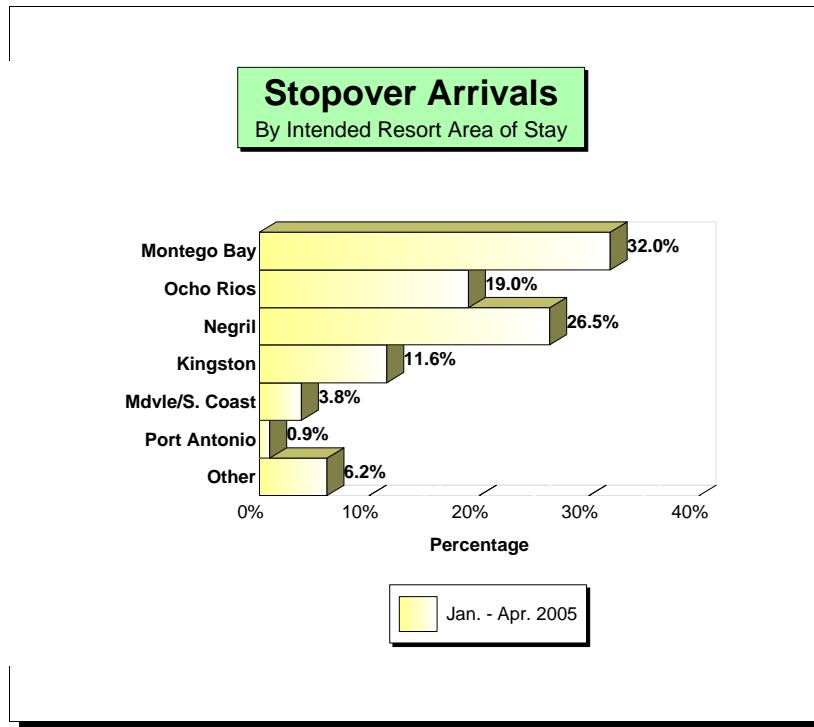
