TOURIST (Stopover Arrivals)

Stopover arrivals in April 2017 were **205,822**, an increase of **9.1%** over the **188,604** recorded in April 2016.

For the January to April period, arrivals increased by **2.3%**, with **790,965** stopovers compared to **773,108** in 2016.

United States

Stopover arrivals from the United States market recorded a **8.9%** increase in April 2017, with a total of **132,638** arrivals compared to the **121,816** arrivals who visited in April 2016. All marketing regions recorded increased arrivals, the Northeast with **62,508** grew by **7.4%**, the South with **32,898** grew by **17.7%**, the Mid-West with **23,314** grew by **5.2%**, and the West with **13,918** grew by **3.1%**.

For the Winter period, January to April 2017, the US market region has increased by **0.8%**, with **475,472** visitors compared to the **471,571** visitors during the same period in 2016. The Northeast fell by **4.2%**, the Mid-west up by **6.7%**, the South up by **4.4%**, and the West up **1.7%**

Canada

In April 2017, the Canadian market recorded an increase in arrivals of **3.8%**, with **38,469** stopovers compared to **37,075** in April 2016.

Stopover arrivals from Atlantic Canada fell by **12.0%**; the main provinces of Nova Scotia decreased by **12.4%**, over April 2016 and those from New Brunswick increased by **6.7%**.

Stopover arrivals from Central Canada increased by **5.4%**; the leading province of Ontario up by **4.7%**, and the second most important Canadian province of Quebec up by **10.1%**.

Stopover arrivals from Western Canada rose by **13.9%**; the main province of Alberta recorded an increase of **21.3%**, and arrivals from British Columbia declined by **8.9%**.

Cumulatively, the Canadian market with **172,077** visitors recorded an increase of **5.7%** or **9,230** more visitors than in 2016. The top producing provinces of Ontario with **114,164** rose by **9.9%**, and Quebec, with **19,524** visitors rose by **2.5%**

Europe

The European market region recorded an increase of **16.2%** in April 2017, with **24,741** stopover arrivals compared to the **21,290** recorded in April 2016.

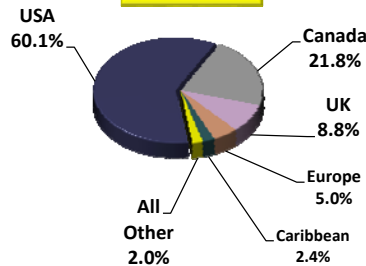
In the Northern European region, the main visitor producing countries, United Kingdom, with **17,239** arrivals, rose by **14.2%** and Ireland with **241** arrivals rose by **29.6%**.

In the South-Western European region, Germany with **2,336** visitor arrivals increased by **23.3%**, Italy with **1,295** arrivals rose by **19.8%**, the Netherlands with **601** arrivals fell by **3.4%**, and France with **755** visitors increased by **47.1%**.

Stopover arrivals from Central-East Europe with **416** arrivals fell by **12.1%**.

For the Winter period, January to April 2017, arrivals from the European market grew by **4.2%**. Total stopover arrivals were **108,759** compared to **104,380** in 2016. Northern Europe fell by **2.1%**, moving from **78,760** in 2016 to **77,112** in 2017. Arrivals from the South/West region increased by **18.3%** with **27,459** arrivals, and those from the Central/East region increased by **74.4%** with **4,188** arrivals.

Latin America

Arrivals from Latin America increased by **28.0%** in April 2017, with a total of **2,675** stopovers compared to **2,090** in April 2016.

From the Central American region, stopover arrivals increased by **4.8%** with **803** arrivals. Mexico with **331** arrivals declined by **12.0%**, while Panama with **171** rose by **32.6%**.

From the South American region, stopover arrivals grew by **41.4%** with **1,872** arrivals. Chile with **444** arrivals increased by **30.2%**, Argentina with **429** arrivals grew by **38.8%** and Brazil with **382** increased by **65.4%**.

Cumulatively, January to April 2017, stopover arrivals from Latin America increased by **9.3%**, with a total of **10,540** arrivals compared to **9,644** in 2016.

Stopovers from Central America declined by **32.1%**. The main Central American countries of Mexico declined by **15.8%** and Panama increased by **11.2%**.

Stopovers from South America increased by **40.0%** with **7,755** arrivals, The top producing countries of Argentina with **2,149** arrivals grew by **70.3%**, Chile with **1,990** arrivals grew by **25.7%**, and Brazil with **1,618** increased by **84.7%**.

The Caribbean

Stopover arrivals to Jamaica from the Caribbean region rose by **20.1%** in April 2017 with a total of **6,013** visitors, compared to **5,005** in April 2016.

The Cayman Islands and Trinidad & Tobago continued to be the major visitor producing Caribbean countries in April 2017 with **1,656** and **1,076** stopover arrivals, respectively.

Cumulatively, stopovers for the January - April 2017 period fell by **3.0%** moving down from **19,300** in 2016 to **18,725** in 2017.

Asia

The Asian market increased by **5.0%** in April 2017 with a total of **776** stopovers compared to **739** in April 2016.

China, India, and Japan, are the major visitor-producing countries with **333**, **192** and **125** stopovers arriving from each country, respectively.

For the January to April 2017 period, stopover arrivals from Asia grew by **7.1%**, with **3,484** arrivals compared to **3,254** arrivals in 2016.

Other Countries

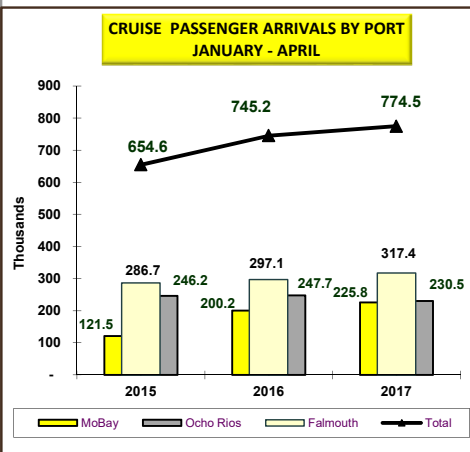
Overall, stopover arrivals from other countries declined by **9.7%** in the January to April 2017 period. Of the Other Countries, Australia provided the most stop-over arrivals to Jamaica, with **809** visitors in 2017 compared to **1,016** in 2016. This represents a decrease of **20.4%**.

Market Share

The market share of stopover visitors for the winter period, January to April 2017 was as follows: USA **60.1%**; Canada **21.8%**; UK **8.8%**; Continental Europe **5.0%**, the Caribbean **2.4%**; and the others, including Latin America and Asia **2.0%**.

Cruise Passengers

A total of **141,792** cruise passengers visited Jamaica in April 2017. This represented a **7.5%** increase over the **131,898** for April 2016.



For April 2017, Cruise passengers visiting the port of Falmouth increased by **10.2%**. Cruise passengers visiting the port of Montego Bay increased by **16.8%** and those visiting the port of Ocho Rios declined by **5.9%**.

The winter period, January to April 2017 saw **774,519** cruise passenger arrivals at the three major ports, an increase of **29,302** passengers or **3.9%**.

Length of Stay

The average length of stay of **Foreign National** arrivals in April 2017 was **7.9** nights which was the same level as in April 2016. The average length of stay in hotels was **6.6** nights in April 2017, which was the same level as in April 2016.

The average length of stay of **Non-Resident Jamaican** arrivals in April 2017 was **14.3** nights compared to **14.2** in April 2016. The average length of stay in hotels in April 2017 was **7.6** nights, which was the same level as in April 2016.

During the January to April 2016 period the average length of stay of Foreign National arrivals in all types of accommodations was **8.2** nights compared to **8.3** nights in 2016. For the Non-Resident Jamaican arrivals the average length of stay was **15.0** nights compared to **14.9** nights in 2016.

Purpose of Visit

During the winter period January to April 2017, **90.9%** or **680,801** of the **748,790 Foreign Nationals** visited Jamaica for Leisure, **4.5%** were on Business, **4.2%** were on Other purposes of travel and **0.4%** did not state their purpose of travel.

A total of **32,944** or **78.1%** of the **42,175 Non-Resident Jamaicans** were visiting for Leisure, **4.6%** were on Business, **14.6%** were on Other purposes of travel and **2.7%** failed to provide a reason for travel.

Year to date January to April 2017, **90.2%** or a total of **713,745** of the total stopover arrivals of **790,965** visited Jamaica for Leisure, **4.5%** were on Business, **4.7%** were on Other purposes of travel and **0.6%** did not state their purpose of travel.

Intended Resort Area of Stay

Of the **205,822** stopover arrivals visiting Jamaica in April 2017, the resort area of Montego Bay welcomed **73,678** arrivals or **35.8%**; Ocho Rios received **50,560** or **24.6%**, Negril welcomed **37,132** or **18.0%**; and **20,911** or **10.2%** visited Kingston. The remaining **11.4%** stayed in the Mandeville/South Coast, Port Antonio resort regions and Other areas in Jamaica.

Between January and April 2017, the pattern remained the same. Montego Bay, Negril, and Ocho Rios accounted for **628,673** or **79.5%** of the stopover arrivals.

Type of Airlines used

Of the **790,965** stopover visitors to Jamaica in the winter period, January to April 2017, **729,398** or **92.2%** used scheduled airlines, while **61,567** or **7.8%** used chartered flights.

During the corresponding period in 2016 the percentage distribution was: **92.4%** - used scheduled airlines and **7.6%** - used chartered flights.

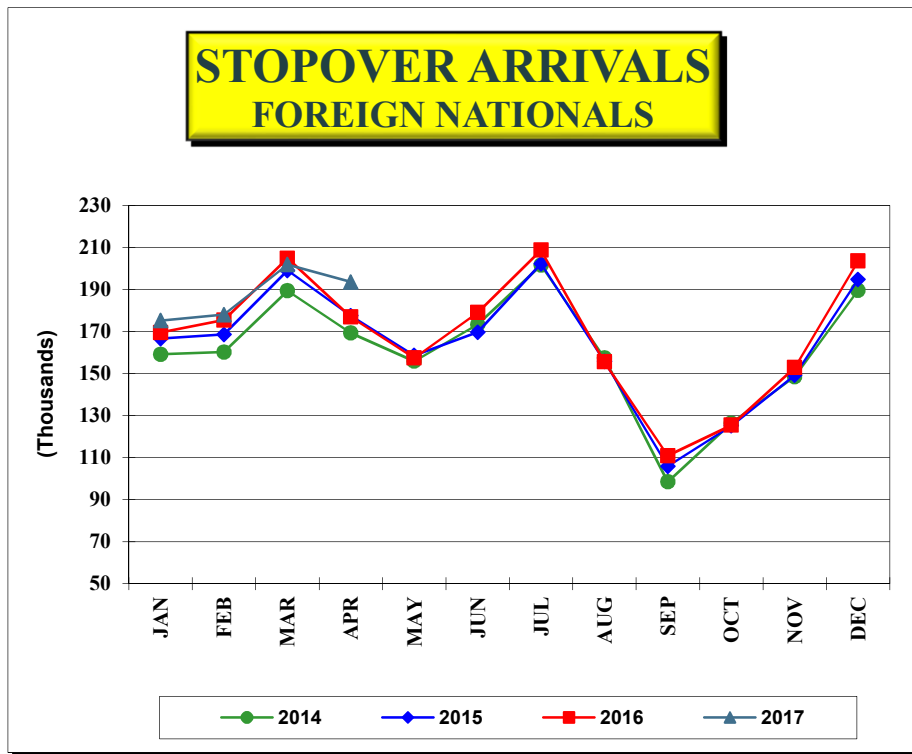

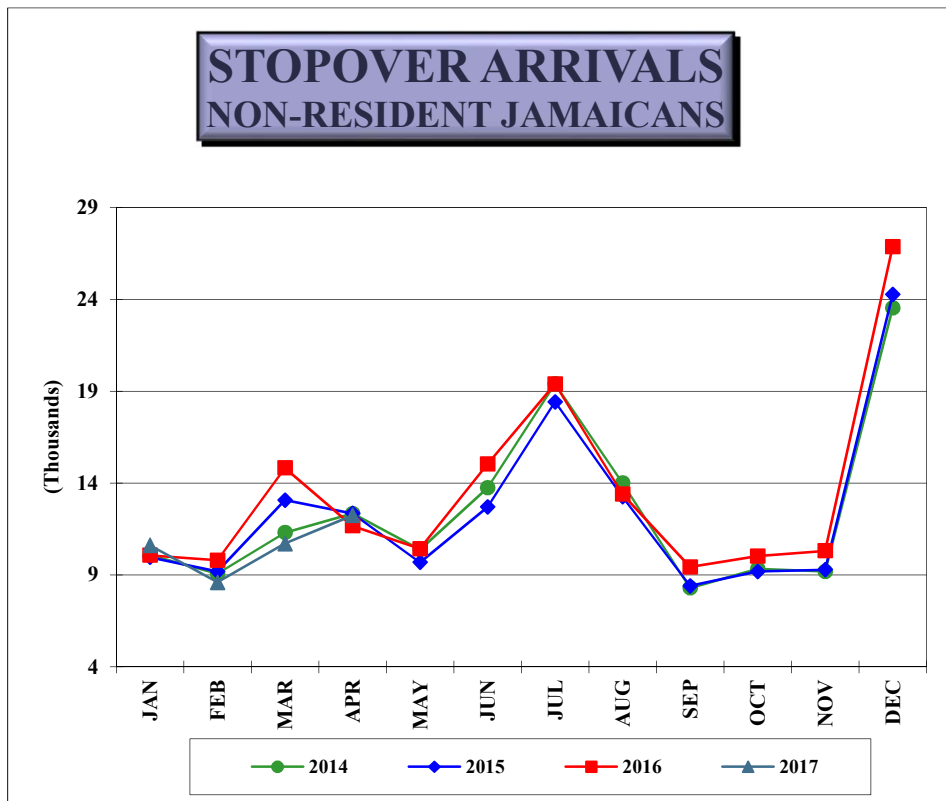

STOPOVER ARRIVALS BY PURPOSE OF VISIT JANUARY - APRIL 2017

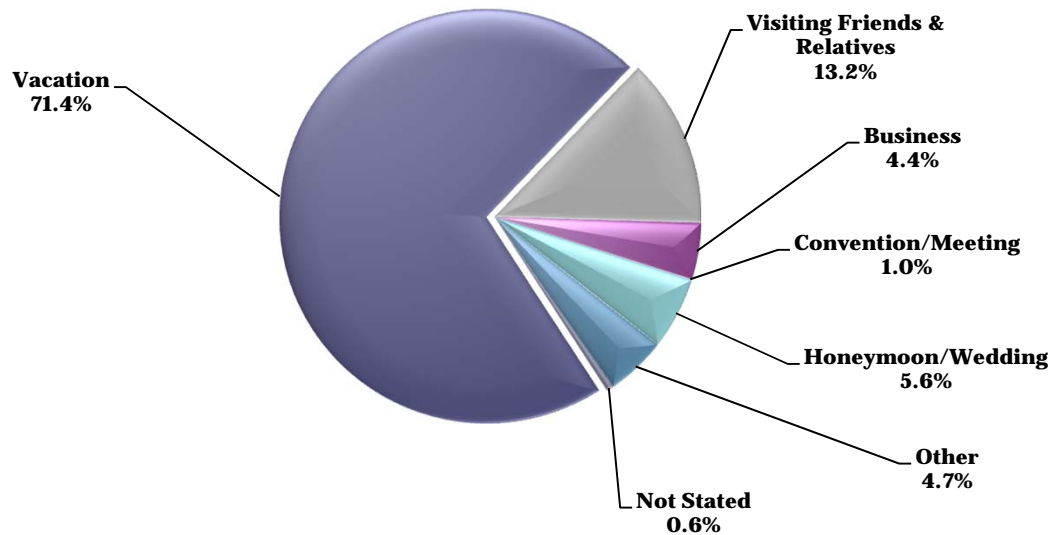

STOPOVER VISITORS BY MARKET SHARE

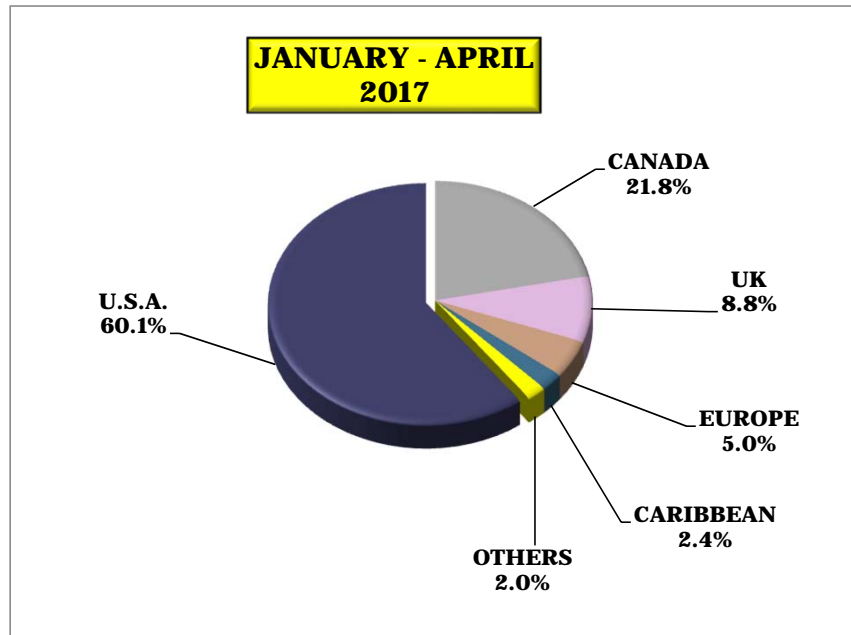

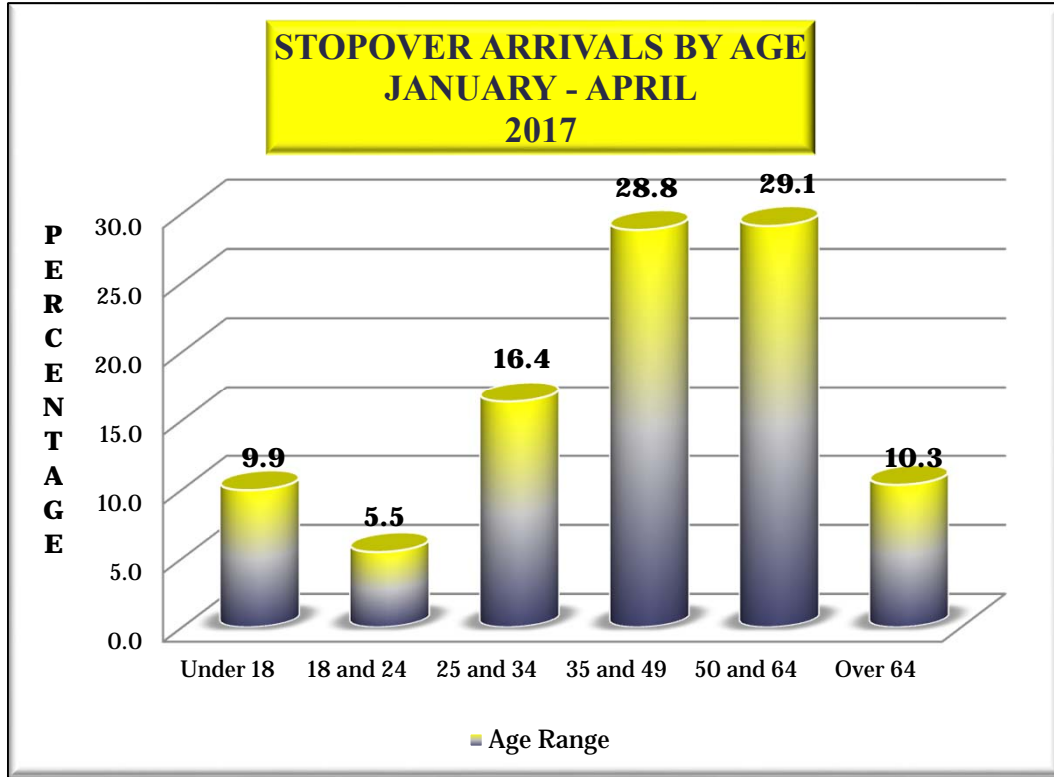

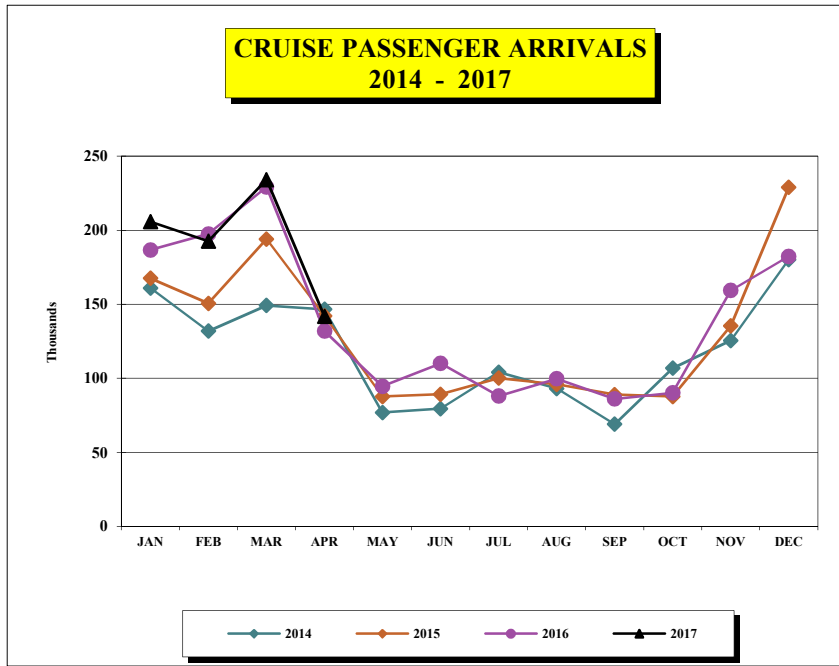

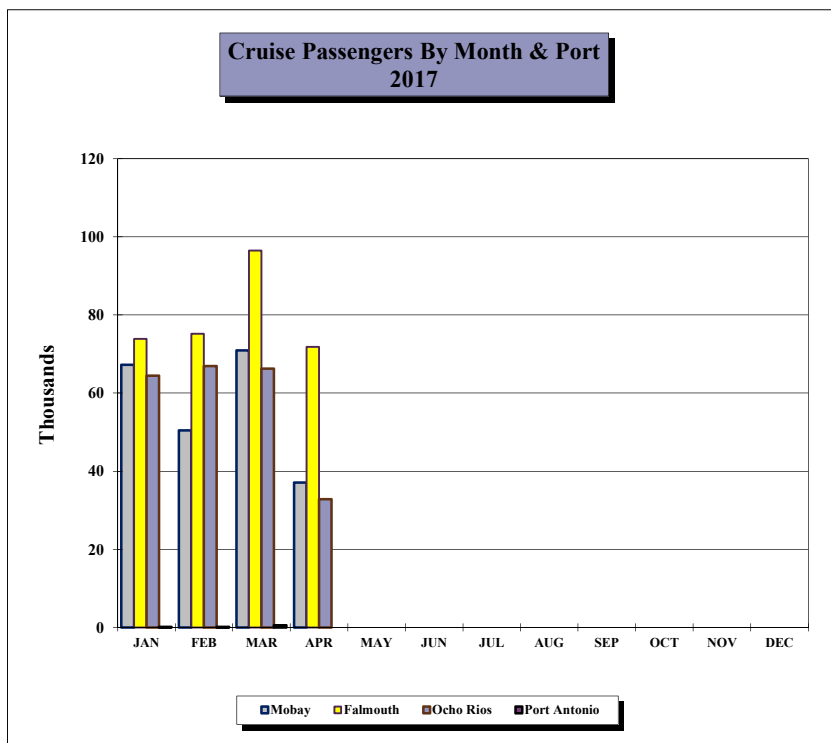

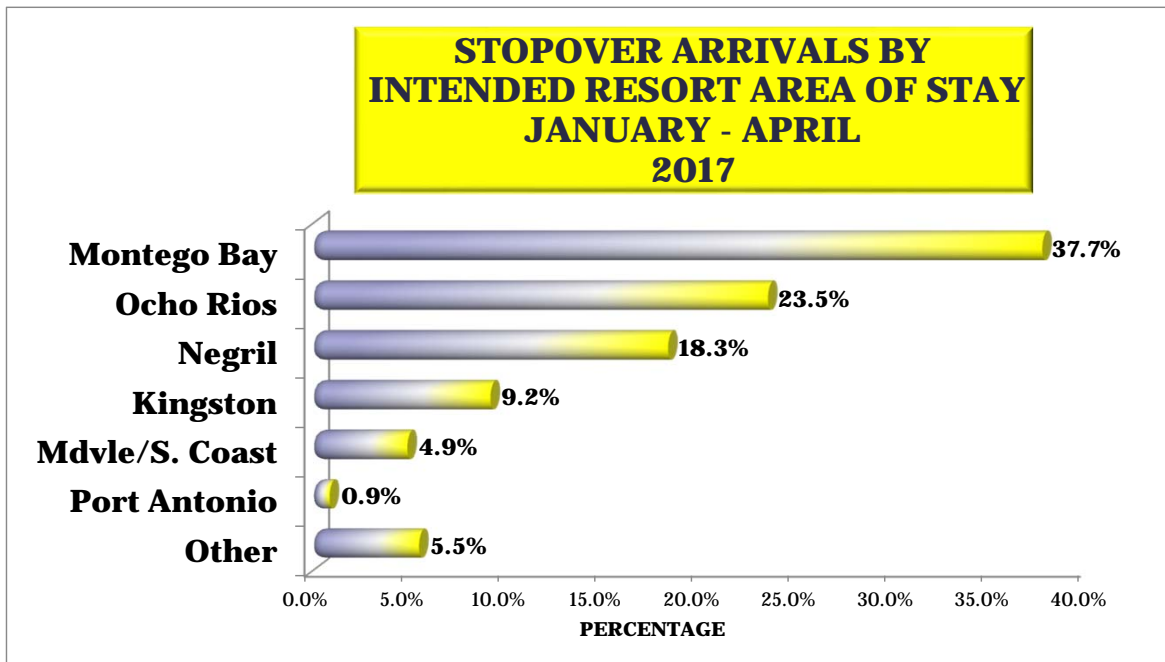
