TOURIST (Stopover Arrivals)

Stopover arrivals in May 2019 were **210,664** an increase of **7.8%** or **15,173** additional arrivals over the **195,491** recorded in May 2018.

For the January to May period, arrivals increased by **12.3%**, with **1,151,795** stopovers compared to **1,025,227** in 2018.

United States

Stopover arrivals from the United States market recorded a double digit increase of **10.7%** for May 2019, with a total of **148,519** arrivals compared to the **134,187** arrivals who visited in May 2018. All the US marketing regions recorded increases in arrivals, the Northeast with **60,876** grew by a remarkable **14.3%**, the South with **44,326** grew by **13.0%**, the Midwest with **22,930** grew by **0.8%**, and the West with **20,387** grew by **7.5%**.

For the January to May period, the US market region has grown by **17.7%**, with **759,054** visitors, which is **114,265** more visitors compared to the **644,789** visitors that visited during the same period in 2018 and **161,136** or **26.94%** more than the **597,918** in 2017. The Northeast has grown by **21.7%**, the Midwest up by **13.2%**, the South up by **17.6%**, and the West up by **12.6%**.

Canada

In May 2019, the Canadian market recorded a decrease in arrivals of **3.9%**, with **27,089** stopovers compared to **28,198** in May 2018.

Stopover arrivals from Atlantic Canada grew by **19.5%**; the main provinces of Newfoundland grew by **22.3%**, over May 2018 and those from Nova Scotia increased by **5.0%**.

Stopover arrivals from Central Canada decreased by **3.5%**; the leading province of Ontario decreased by **1.5%**, and the second most important Canadian province of Quebec decreased by **17.3%**.

Stopover arrivals from Western Canada fell by **20.9%**; the main province of Alberta recorded a decrease of **19.1%**, and the arrivals from British Columbia decreased by **9.7%**.

Cumulatively, the Canadian market with **204,935** visitors recorded an increase of **2.3%** or **4,685** more visitors than in 2018. The top producing provinces of Ontario with **141,862** rose by **3.5%**, and those from Quebec, with **24,312** visitors fell by **0.8%**.

Europe

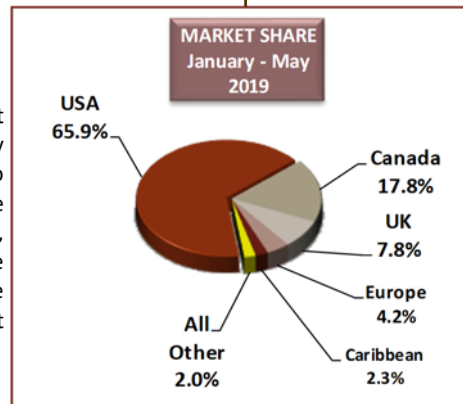
The European market region recorded a decrease of **1.8%** in May 2019, with **23,532** stopover arrivals compared to the **23,973** recorded in May 2018.

In the Northern European region, the main visitor producing countries, United Kingdom, with **18,858** arrivals, grew by **6.4%**, and Ireland with **222** arrivals grew by **63.2%**.

In the South-Western European region, Germany with **1,202** visitor arrivals decreased by **53.8%**, France with **631** fell by **2.8%** the Netherlands with **597** arrivals decreased by **10.8%** and Italy with **508** fell by **9.4%**.

Stopover arrivals from Central-East Europe with **298** arrivals fell by **25.1%**.

For the January to May 2019 period, arrivals from the European market region grew by **2.8%**. Total stopover arrivals were **138,358** compared to **134,574** in 2018. Northern Europe rose by **5.5%**, moving from **90,181** in 2018 to **95,170** in 2019. Arrivals from the South/West region fell by **6.3%**, with **35,735** arrivals, and those from Central/East region increased by **19.4%** with **7,453** arrivals.



Latin America

Arrivals from Latin America increased by **54.5%** in May 2019, with a total of **4,624** stopovers compared to **2,992** in May 2018.

From the Central American region, stopover arrivals grew by **19.0%** with **946** arrivals. Mexico with **361** arrivals fell by **1.6%**, and Panama with **254** rose by **31.4%**.

From the South American region, stopover arrivals rose by **67.4%** with **3,678** arrivals. Brazil with **1,307** arrivals increased by **172.3%**, Argentina with **705** grew by **9.6%**, and Chile with **514** arrivals grew by **19.8%**.

Cumulatively, January to May 2019, stopover arrivals from Latin America increased by **15.2%**, with a total of **17,027** arrivals compared to **14,784** in 2018.

Stopover from Central America with **4,230** arrivals grew by **15.9%**. The main producing countries of Mexico and Panama increased by **11.2%** and **20.0%** respectively.

Stopovers from South America grew by **14.9%** with **12,797** arrivals. The top producing countries of Brazil with **3,027** arrivals grew by **8.0%** Argentina with **2,926** fell by **13.3%**, and Chile with **2,682** grew by **24.7%**.

The Caribbean

Stopover arrivals to Jamaica from the Caribbean region were grew by **14.9%** in May 2019 with a total of **5,778** visitors, compared to **5,027** in May 2018.

The Cayman Islands and Trinidad & Tobago continued to be the major visitor producing Caribbean countries in May 2019 with **1,526** and **1,043** stopover arrivals, respectively.

Year to date, stopovers for the January to May period increased by **4.4%** moving up from **25,035** in 2018 to **26,136** in 2019.

Asia

The Asian market rose by **3.1%** in May 2019 with a total of **664** stopovers compared to **644** in May 2018.

China, India, and Japan are the major visitor-producing countries with **266**, **185** and **120** stopovers arriving from each country, respectively.

For the January to May 2019 period, stopover arrivals from Asia grew by **15.0%** with **3,768** arrivals compared to **3,276** in 2018.

Other Countries

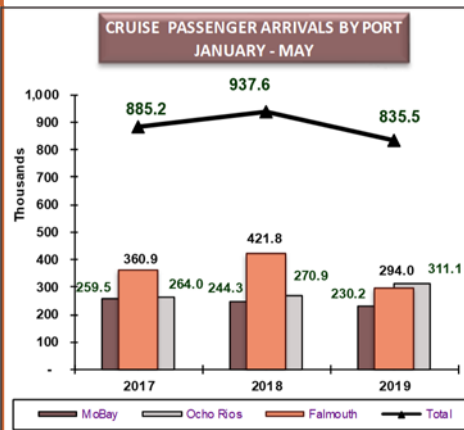
Overall, stopover arrivals from other countries fell by **0.1%** with **2,517** arrivals, for the January to May 2019 period. Of the Other Countries, Australia provided the most stop-over arrivals to Jamaica, with **938** visitors compared to **947** in 2018. This represents a decrease of **1.0%**.

Market Share

The market share of stopover visitors for January to May 2019 was as follows: USA **65.9%**; Canada **17.8%**; UK **7.8%**; Continental Europe **4.2%**, the Caribbean **2.3%**; and the others, including Latin America and Asia **2.0%**.

Cruise Passengers

A total of **73,680** cruise passengers visited Jamaica in May 2019. This represented a **41.0%** decrease over the **124,781** who visited in May 2018.



For May 2019, Cruise passengers visiting the port of Falmouth fell by **45.8%** with **30,235** passengers, those visiting the port of Ocho Rios fell by **11.3%** with **27,839** passengers and the Montego Bay port fell by **58.5%** with **15,606** passengers.

Year-to-date, January to May 2019 saw **835,536** cruise passenger arrivals visiting our shores, a decline of **10.9%** or **102,022** less cruise passengers.

Length of Stay

The average length of stay of **Foreign National** arrivals in May 2019 was **7.1** nights, compared to **7.2** nights in May 2018. The average length of stay in hotels was **5.7** nights in May 2019, compared to **5.9** nights in May 2018.

The average length of stay of **Non-Resident Jamaican** arrivals in May 2019 was **14.7** nights compared to **15.2** in May 2018. The average length of stay in hotels in May 2019 was **7.4** nights, compared to **7.5** nights in May 2018.

During the January to May 2019 period, the average length of stay for Foreign National arrivals in all types of accommodations was **7.5** nights compared to **7.7** nights in 2018. For the Non-Resident Jamaican arrivals the average length of stay was **14.8** nights compared to **15.6** nights.

Purpose of Visit

During the month of May 2019, **91.3%** or **180,138** of the **197,332 Foreign Nationals** visited Jamaica for Leisure, **4.0%** were on Business, **4.2%** were on Other purposes of travel and **0.5%** did not state their purpose of travel.

A total of **10,195** or **76.5%** of the **13,332 Non-Resident Jamaicans** were visiting for Leisure, **4.2%** were on Business, **16.2%** were on Other purposes of travel and **3.1%** failed to provide a reason for travel.

Year-to-date January to May 2019, **90.6%** or a total of **1,042,956** of the total stopover arrivals of **1,151,795** visited Jamaica for Leisure, **3.9%** were on Business, **4.8%** were on Other purposes of travel and **0.7%** did not state their travel purpose.

Intended Resort Area of Stay

Of the **210,664** stopover arrivals visiting Jamaica in May 2019, the resort area of Montego Bay welcomed **80,677** arrivals or **38.3%**; Ocho Rios received **41,708** or **19.8%**, Negril welcomed **41,412** or **19.7%**; and **20,545** or **9.8%** visited Kingston. The remaining **12.6%** stayed in the Mandeville/South Coast, Port Antonio resort regions and Other areas in Jamaica.

Between January to May 2019, the combination of Montego Bay, Negril, and Ocho Rios accounted for **907,242** or **78.8%** of the total stopover arrivals.

Type of Airlines used

Of the **1,151,795** stopover visitors to Jamaica in the January to May 2019, **1,061,066** or **92.1%** used scheduled airlines, while **90,729** or **7.9%** used chartered flights.

During the corresponding period in 2018 the percentage distribution was: **92.7%** - used scheduled airlines and **7.3%** - used chartered flights.

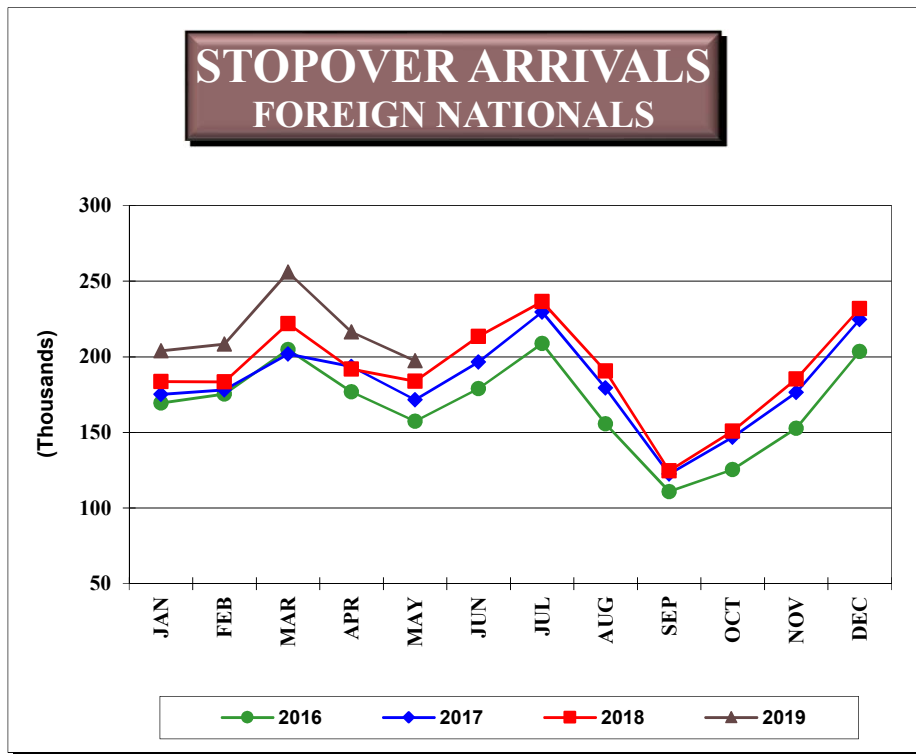

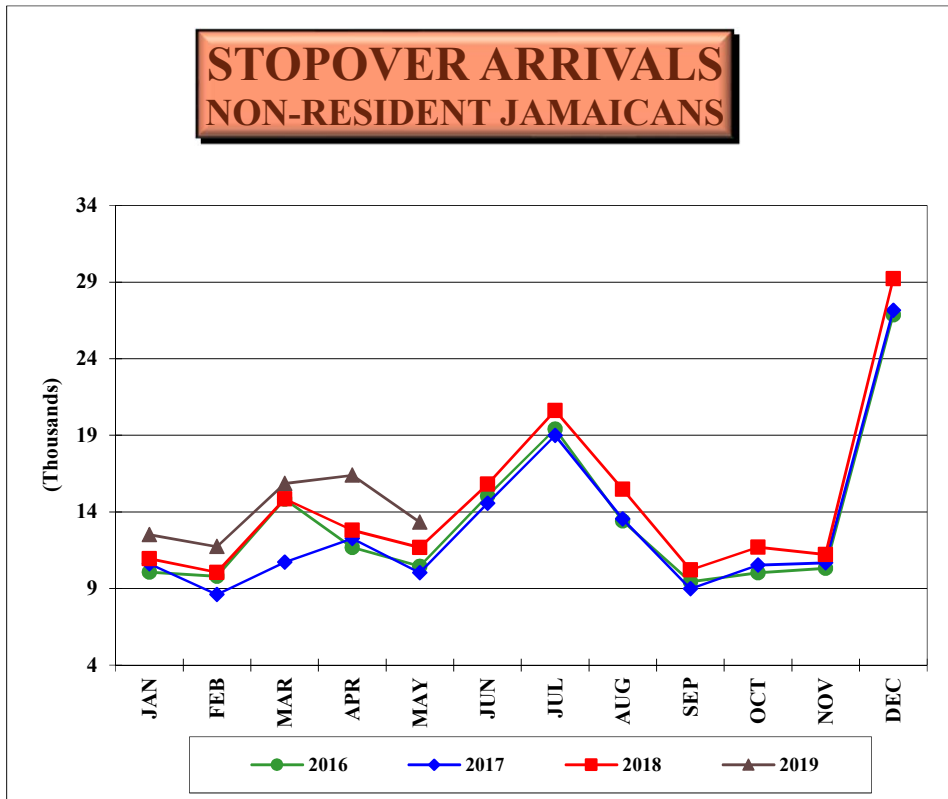

STOPOVER ARRIVALS BY PURPOSE OF VISIT JANUARY - MAY 2019

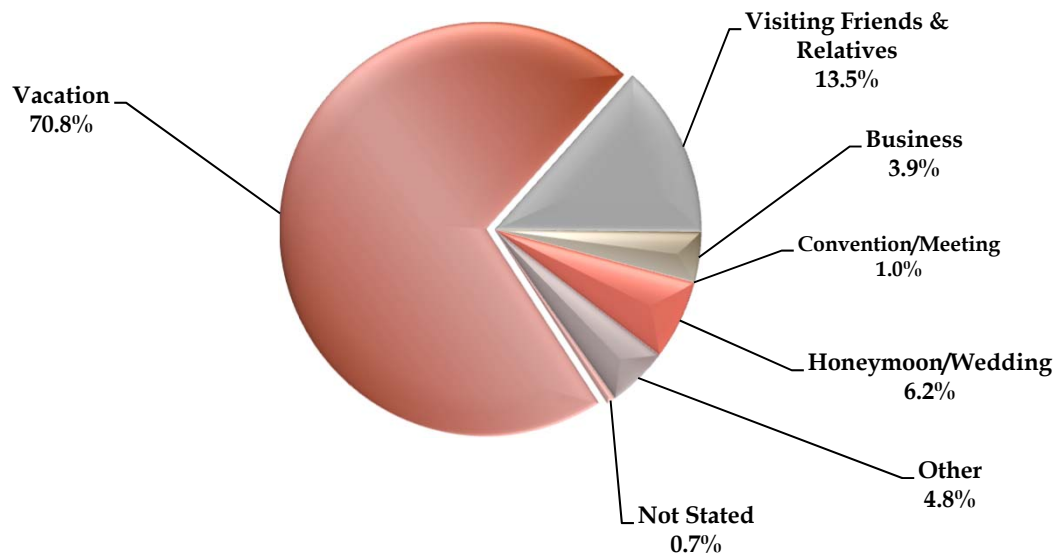

STOPOVER VISITORS BY MARKET SHARE

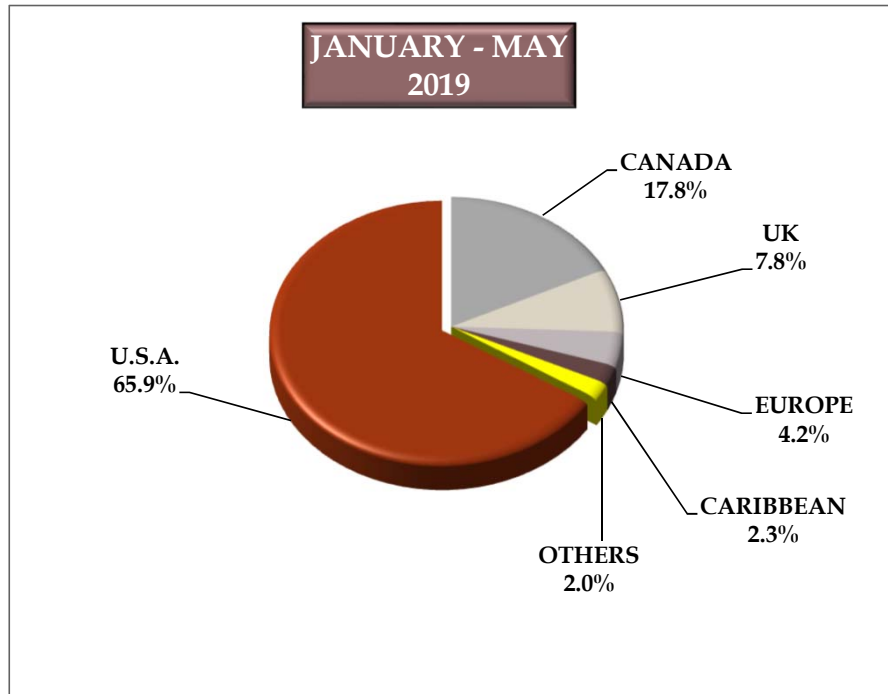

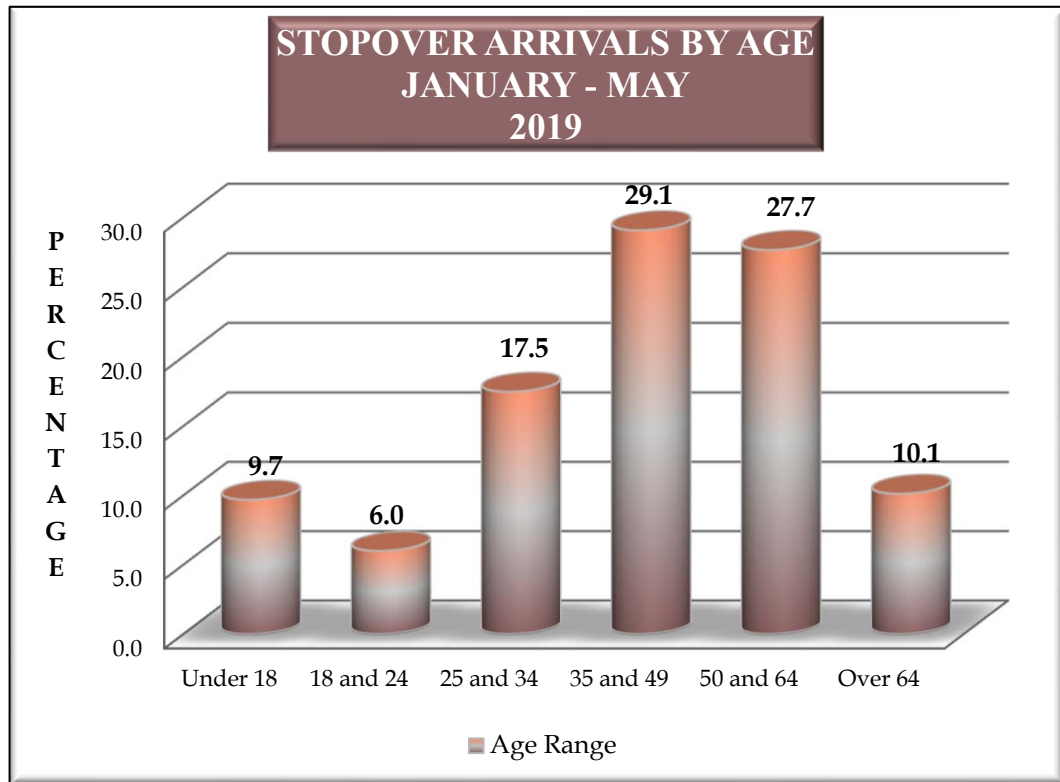

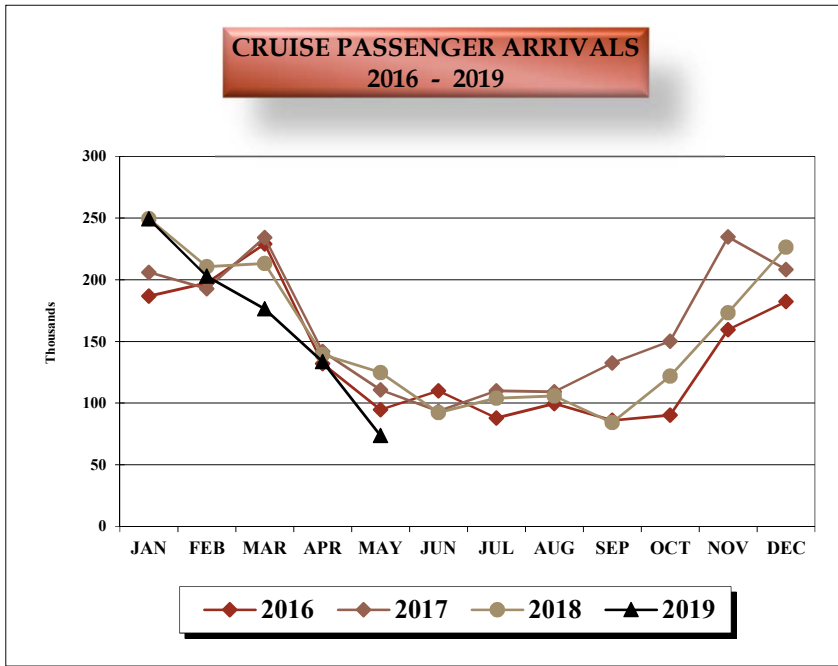

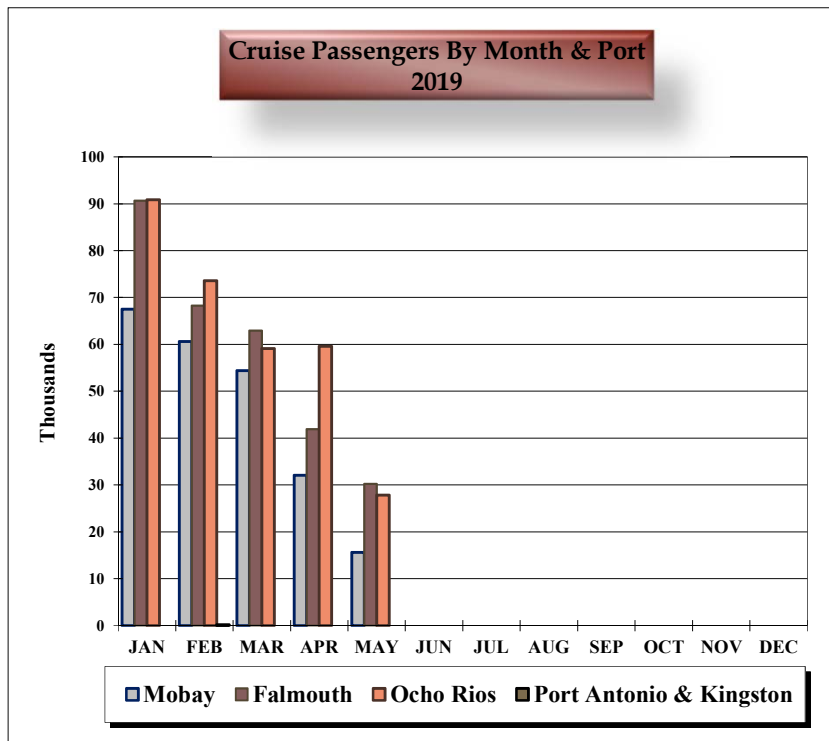

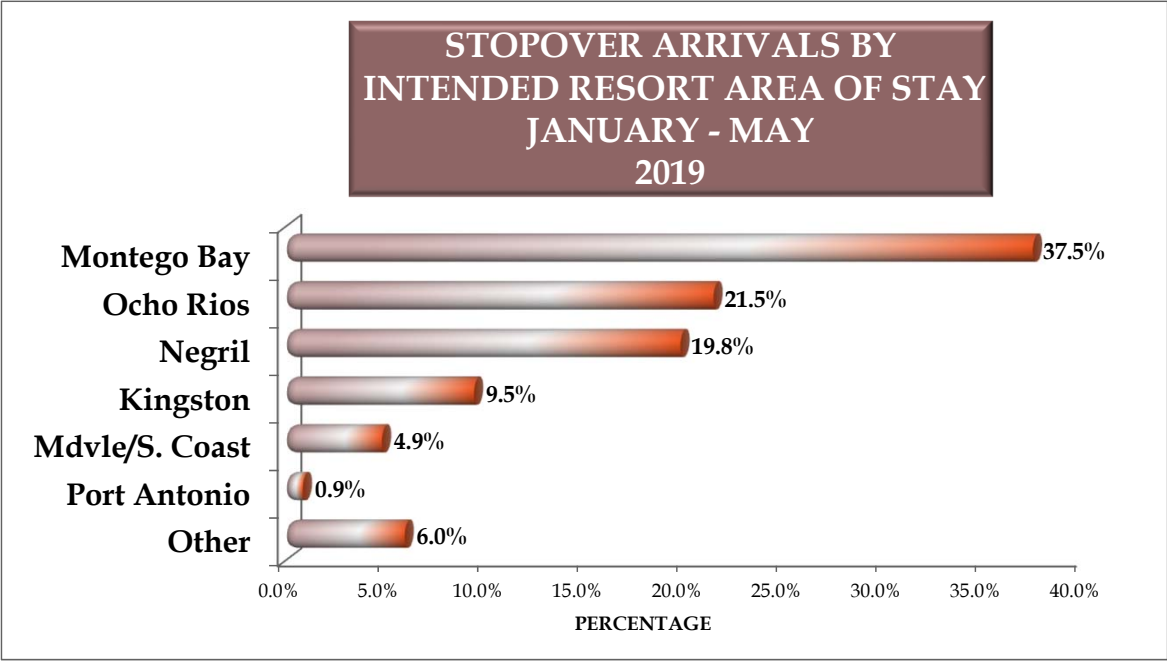
