IN JUNE 2016.....

- Stopover arrivals up 6.4%
- US Market up 8.4%
- Canada down 6.2%
- Europe up 3.6%
- Cruise Passenger up by 23.5%

TOURIST (Stopover Arrivals)

Stopover arrivals in June 2016 were **194,088**, an increase of **6.4%** over the **182,364** recorded in June 2015.

For the first half of 2016, January to June, arrivals increased by **2.5%**, with **1,135,080** stopovers compared to **1,107,174** in 2015.

United States

Stopover arrivals from the United States market recorded an **8.4%** increase in June 2016 with a total of **147,053** arrivals compared to the **135,702** arrivals who visited in June 2015. All marketing regions recorded increased arrivals. The Northeast with **54,217** increased by **3.7%**, the South with **45,383** increased by **10.3%**, the Mid-west with **23,616** increased by **9.6%**, and the West with **23,837** increased by **14.9%**.

Year-to-date, January to June 2016, the US market region has grown by **5.6%**, with **731,983** visitors compared to the **693,090** visitors during the same period in 2015. This was **38,893** more arrivals than in 2015, as well as, **75,421** more than in 2014. The Northeast was up by **3.0%**, the South up by **6.2%**, the Mid-west up by **4.4%**, and the West was up **17.2%**.

Canada

In June 2016, the Canadian market recorded a fall in arrivals of **6.2%**, with **17,879** stopovers compared to **19,068** in June 2015.

Stopover arrivals from Atlantic Canada grew by **51.8%**, the main provinces of Newfoundland increased by **86.0%**, over June 2015 and those from Nova Scotia increased by **21.1%**.

Stopover arrivals from Central Canada fell by **7.9%**, the leading province of Ontario fell by **9.6%**, and the second most important Canadian province of Quebec recorded a increase of **2.7%**.

Stopover arrivals from Western Canada fell by **4.7%**, Alberta recorded a decline of **6.5%**, and arrivals from British Columbia fell by **11.0%**.

Cumulatively, the Canadian market with **206,013** visitors recorded a decline of **9.8%** or **22,277** less visitors than in 2015. The top producing provinces of Ontario with **135,297** fell by **6.5%**, and Quebec, with **23,355** visitors fell by **19.9%**.

Europe

The European market region recorded an increase of **8.5%** in June 2016, with **20,758** stopover arrivals compared to the **19,125** recorded in June 2015.

In the Northern European region, the main visitor producing countries, United Kingdom, with **15,782** arrivals, rose by **3.6%** and Ireland with **1,068** arrivals increased by **238.0%**.

In the South-Western European region, Germany with **1,205** visitor arrivals increased by **17.0%**, Italy with **542** arrivals grew by **33.5%**, Belgium with **425** arrivals grew by **13.6%**, the Netherlands with **401** visitors fell by **7.4%**, and Spain with **238** arrivals rose by **5.8%**.

Stopover arrivals from Central-East Europe with **313** arrivals rose by **18.1%**.

Year-to-date, January to June 2016 period, arrivals from the European market grew by **7.3%**. Total stopover arrivals were **146,242** compared to **136,338** in 2015, this was **9,904** more arrivals than the **136,338** recorded in 2015. Northern Europe grew by **9.0%**, moving from **103,370** in 2015 to **112,724** in 2016. Arrivals from the South/West region increased by **6.1%** with **30,480** arrivals, and those from the Central/East region declined by **28.5%** with **3,038** arrivals.

Latin America

Arrivals from Latin America fell by **4.9%** in June 2016, with a total of **1,929** stopovers compared to **2,029** in June 2015.

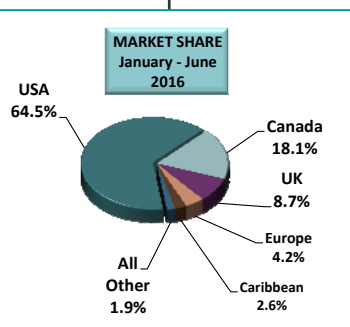
From the Central American region, stopover arrivals fell by **8.8%** with **711** arrivals. Mexico with **310** arrivals fell by **17.6%**, and Panama with **160** fell by **1.2%**.

From the South American region, stopover arrivals fell by **2.5%** with **1,218** arrivals. Chile with **350** arrivals fell by **1.1%** and Colombia with **249** arrivals rose by **14.7%**.

Cumulatively, January to June 2016, stopover arrivals from Latin America decreased by **2.9%**, with a total of **13,626** arrivals compared to **14,032** in 2015.

Stopovers from Central America increased by **16.2%**. The main Central American countries of Mexico, Costa Rica and Panama recorded **-0.4%**, **161.9%** and **-19.6%** respectively.

Stopovers from South America decreased by **12.4%** with **8,192** arrivals, The top producing countries of Chile with **2,322** arrivals fell by **5.1%**, and Argentina with **1,760** arrivals fell by **11.2%**.



The Caribbean

Stopover arrivals to Jamaica from the Caribbean region increased by **5.9%** in June 2016 with a total of **5,274** visitors, compared to **4,981** in June 2015.

The Cayman Islands and Trinidad & Tobago continued to be the major visitor producing Caribbean countries in June 2016 with **1,407** and **786** stopover arrivals, respectively.

Cumulatively, stopovers for the January - June 2016 period grew by **7.4%** moving from **27,513** in 2015 to **29,548** in 2016.

Asia

The Asian market increased by **22.6%** in June 2016 with a total of **739** stopovers compared to **603** in June 2015.

China, Japan, and India are the major visitor-producing countries with **297**, **156** and **148** stopovers arriving from each country, respectively.

For the January to June 2016 period, stopover arrivals from Asia rose by **2.7%**, with **4,620** arrivals compared to **4,498** arrivals in 2015.

Other Countries

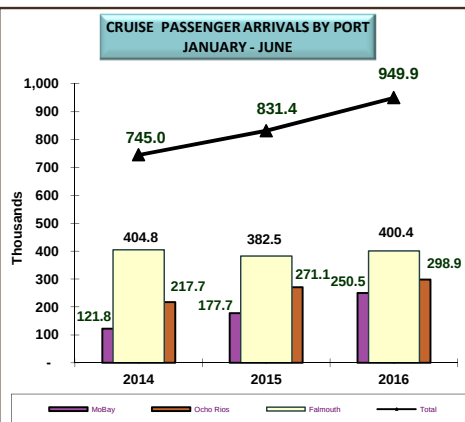
Overall, stopover arrivals from other countries decreased by **10.7%** in the January to June 2016. Of the Other Countries, Australia provided the most stop-over arrivals to Jamaica, with **1,362** visitors in 2016 compared to **1,675** in 2015. This represents a decrease of **18.7%**.

Market Share

The market share of stopover visitors for the January to June 2016 was as follows: USA **64.5%**; Canada **18.1%**; UK **8.7%**; Continental Europe **4.2%**, the Caribbean **2.6%**; and the others, including Latin America and Asia **1.9%**.

Cruise Passengers

A total of **110,086** cruise passengers visited Jamaica in June, 2016. This represented a **23.5%** increase over the **89,162** for June 2015.



For June 2016, Cruise passengers visiting the Falmouth port increased by **20.7%**. Cruise passengers visiting the port of Ocho Rios increased by **111.3%** and those visiting Montego Bay decreased by **4.7%**.

The January to June 2016 period saw **949,883** cruise passenger arrivals at the three major ports, an increase of **118,450** passengers or **14.2%**.

Length of Stay

The average length of stay of **Foreign National** arrivals in June 2016 was **9** nights, this was the same level as in 2015. The average length of stay in hotels was **6.6** nights in June 2016, this was also the same level as in June 2015.

The average length of stay of **Non-Resident Jamaican** arrivals in June 2016 was **18.4** nights compared to **18.3** nights in June 2015. The average length of stay in hotels in June 2016 was **8.5** nights, compared to **8.6** nights in June 2015.

During the January to June 2016 period the average length of stay of Foreign National arrivals in all types of accommodations was **8.3** nights, this was the same level as in 2015. For the Non-Resident Jamaican arrivals the average length of

stay was **15.7** nights compared to **15.1** nights in 2015.

Purpose of Visit

During the period January to June 2016, **90.0%** or **956,456** of the **1,063,230** **Foreign Nationals** visited Jamaica for Leisure, **4.8%** were on Business, **4.6%** were on Other purposes of travel and **0.6%** did not state their purpose of travel.

A total of **57,243** or **79.7%** of the **71,850** **Non-Resident Jamaicans** were visiting for Leisure, **4.1%** were on Business, **13.0%** were on Other purposes of travel and **3.2%** failed to provide a reason for travel.

Year to date January to June 2016, **89.3%** or a total of **1,013,699** of the total stopover arrivals of **1,135,080** visited Jamaica for Leisure, **4.8%** were on Business, **5.1%** were on Other purposes of travel and **0.8%** did not state their purpose of travel.

Intended Resort Area of Stay

Of the **194,088** stopover arrivals visiting Jamaica in June 2016, the resort area of Montego Bay welcomed **62,174** arrivals or **32.0%**; Ocho Rios welcomed **46,910** or **24.2%**; Negril received **36,169** or **18.6%**, and **21,266** or **10.0%** visited Kingston. The remaining **14.2%** stayed in the Mandeville/South Coast, Port Antonio resort regions and Other areas in Jamaica.

Between January and June 2016, the pattern remained the same. Montego Bay, Ocho Rios, and Negril accounted for **878,474** or **77.4%** of the stopover arrivals.

Type of Airlines used

Of the **1,135,080** stopover visitors to Jamaica in the January to June 2016, **1,055,053** or **92.9%** used scheduled airlines, while **80,027** or **7.1%** used chartered flights.

During the corresponding period in 2015 the percentage distribution was: **93.5%** - used scheduled airlines and **6.5%** - used chartered flights.

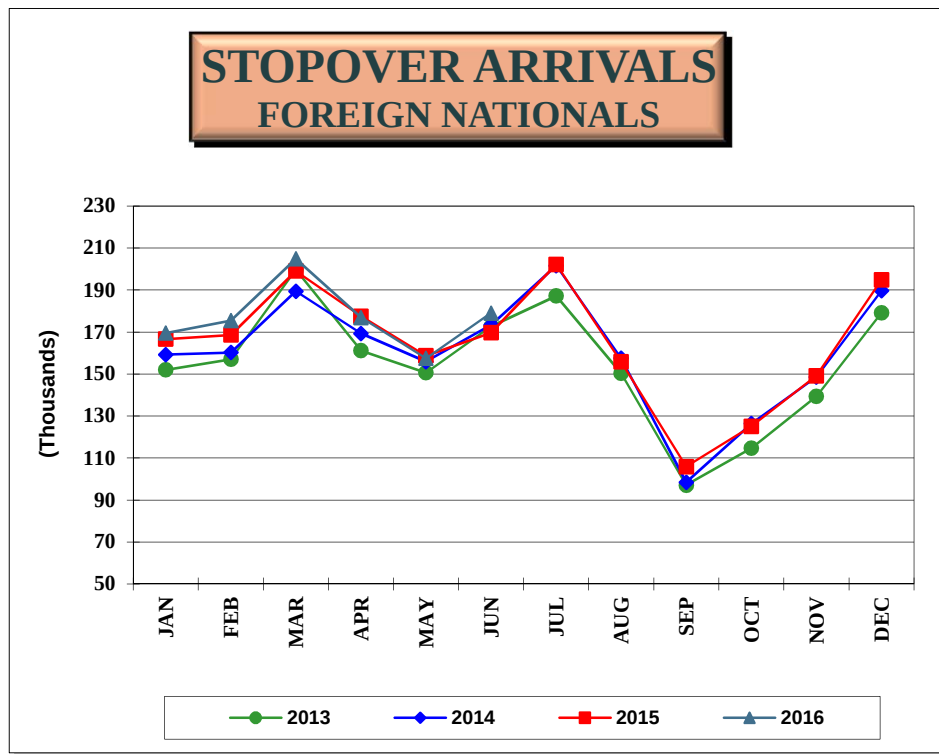

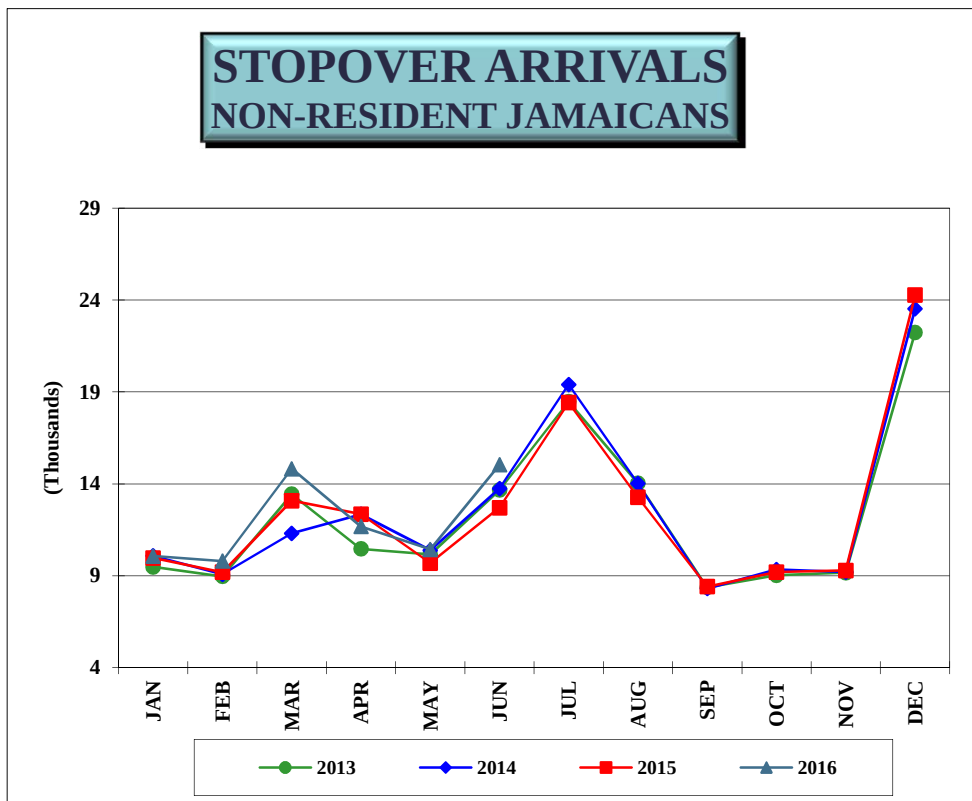

STOPOVER ARRIVALS BY PURPOSE OF VISIT JANUARY - JUNE 2016

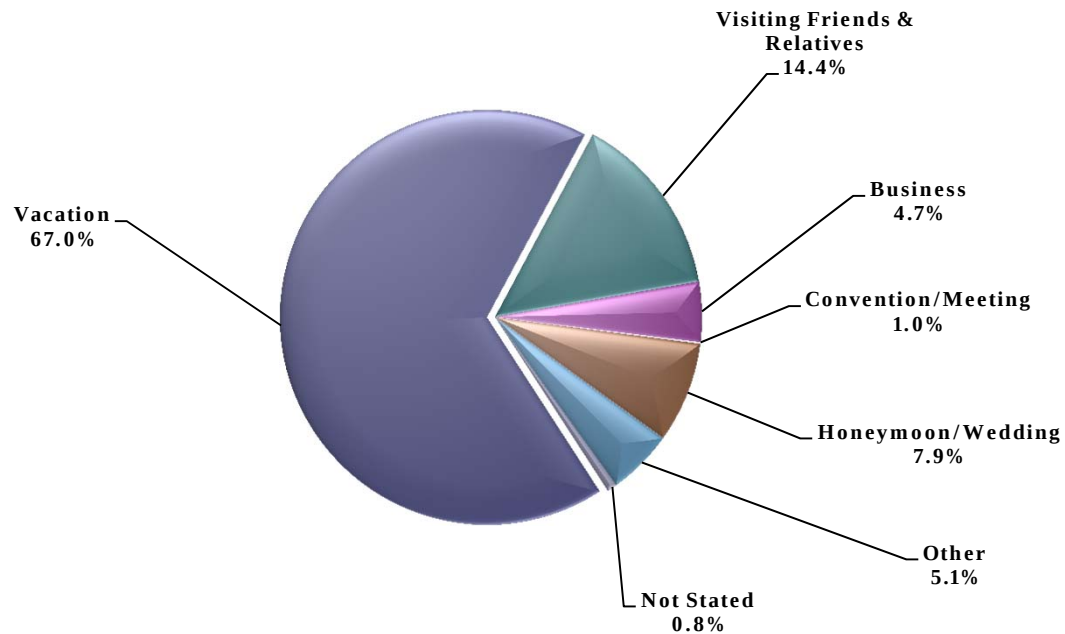

STOPOVER VISITORS BY MARKET SHARE

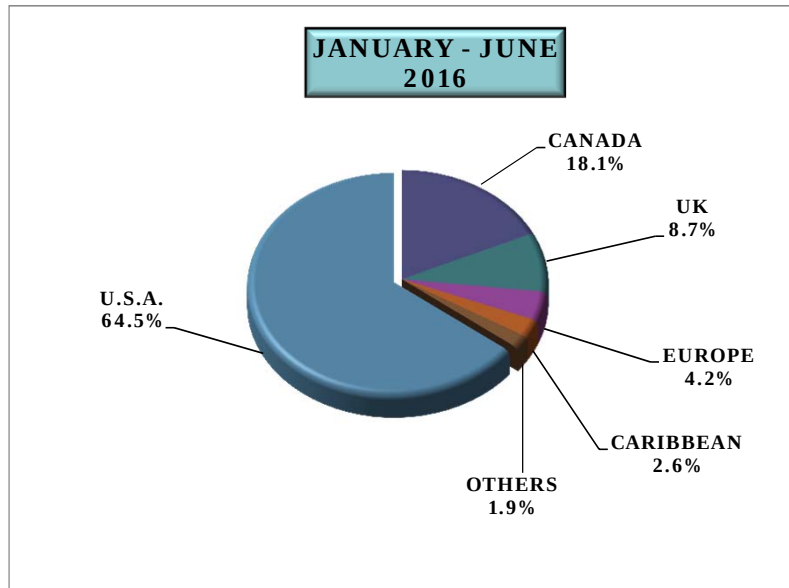

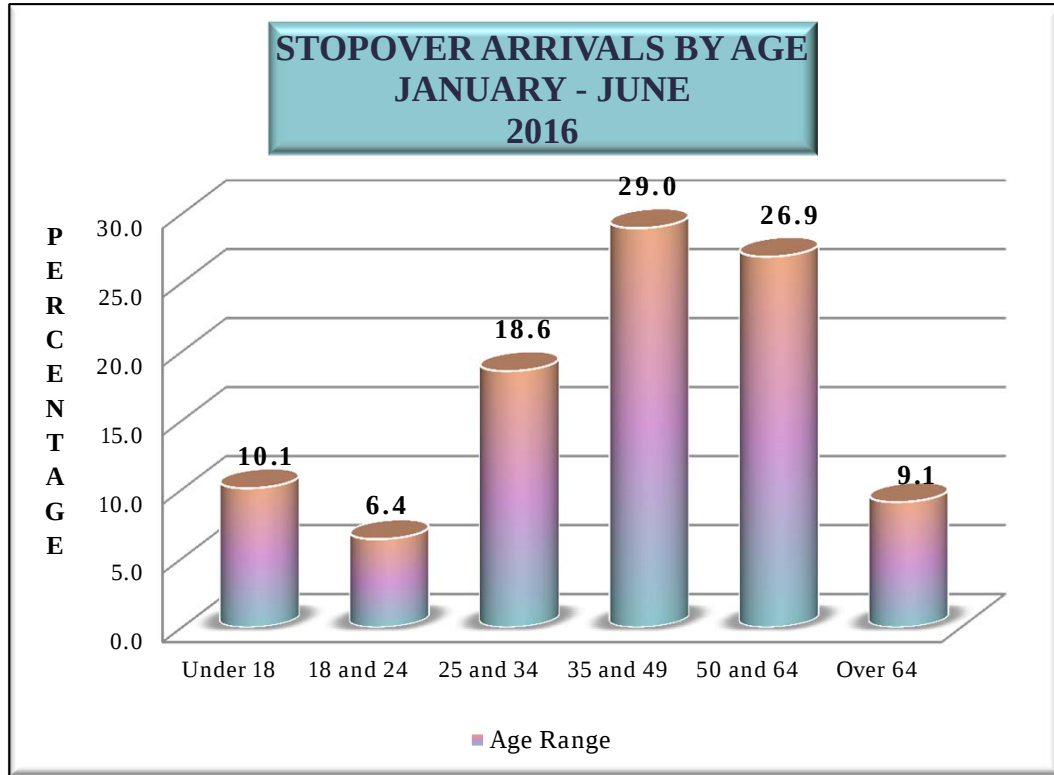

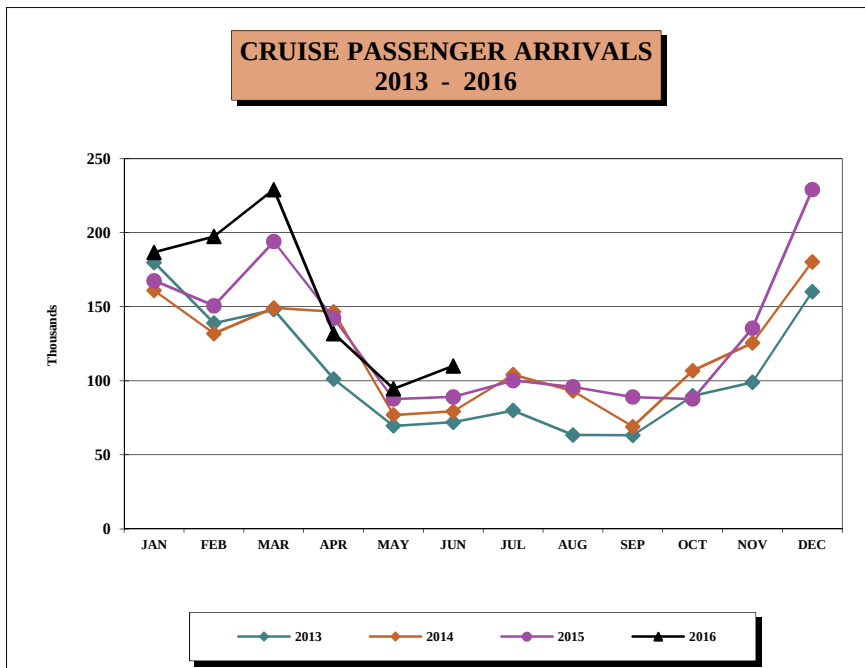

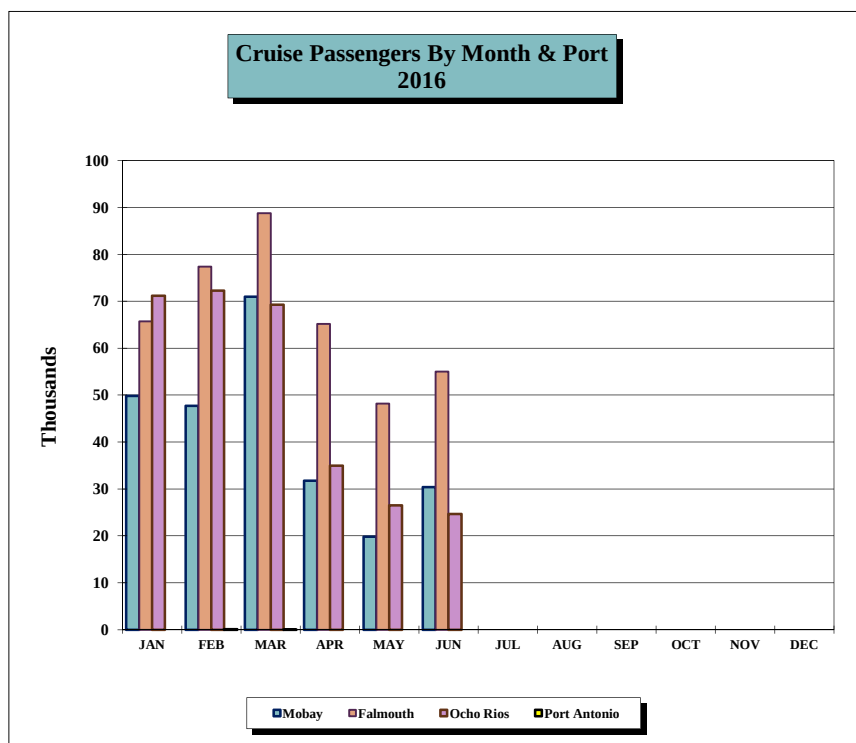

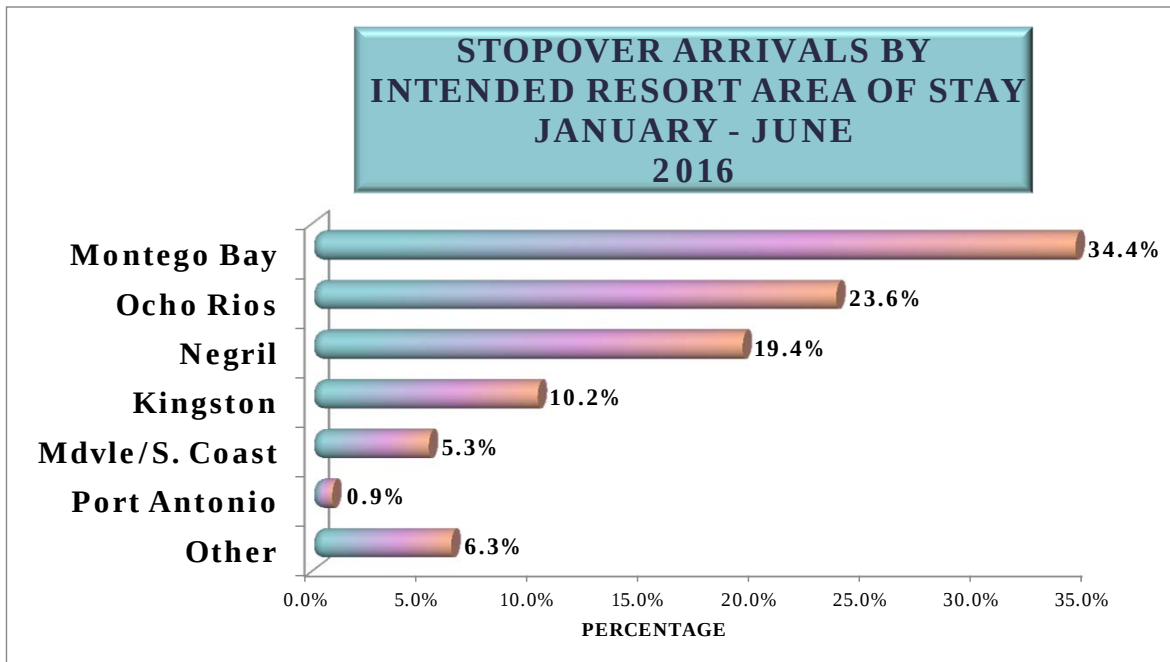
