TOURIST (Stopover Arrivals)

Stopover arrivals in June 2019 were **238,888** an increase of **4.2%** or **9,627** additional arrivals over the **229,261** recorded in June 2018.

For the first two months of summer, May to June, arrivals increased by **5.8%**, with **449,552** stopovers compared to **424,752** in 2018.

For the January to June period, arrivals increased by **10.9%**, with **1,390,683** stopovers, which is **136,195** more arrivals than the **1,254,488** that came in 2018.

United States

Stopover arrivals from the United States market recorded a notable increase of **7.9%** for June 2019, with a total of **186,707** arrivals compared to the **173,109** arrivals who visited in June 2018. All the US marketing regions recorded increases in arrivals, with the exception of the Midwest. The Northeast with **71,251** grew by **11.8%**, the South with **59,055** grew by **10.8%**, and the West with **29,012** grew by **3.4%**. The Midwest with **27,389** declined by **2.4%**.

For the summer period to date, May to June 2019, the US market region recorded a **9.1%** increase in arrivals, with **335,226** visitors compared to the **307,296** visitors during the same period in 2018. The Northeast increased by **13.0%**, the South grew by **11.7%** the Midwest was flat down **0.9%** and the West grew by **5.1%**.

For the January to June period, the US market region has grown by **15.6%**, with **945,761** visitors, which is **127,863** more visitors compared to the **815,898** visitors that visited during the same period in 2018 and **191,179** or **25.3%** more than the **754,582** in 2017. The Northeast has grown by **19.8%**, the South by **15.9%**, the Midwest by **10.8%**, and the West by **10.0%**.

Canada


In June 2019, the Canadian market recorded a decrease in arrivals of **12.9%**, with **19,490** stopovers compared to **22,364** in June 2018.

Stopover arrivals from Atlantic Canada fell by **45.9%**; the main provinces of Newfoundland fell by **69.3%**, over June 2018 and those from Nova Scotia fell by **69.3%**.

Stopover arrivals from Central Canada decreased by **9.9%**; the leading province of Ontario decreased by **9.4%**, and the second most important Canadian province of Quebec decreased by **12.2%**.

Stopover arrivals from Western Canada fell by **31.3%**; the main province of Alberta recorded a decrease of **43.6%**, and the arrivals from British Columbia decreased by **23.7%**.

For the first two months of summer, May to June, arrivals from Canada are down **7.9%** with **46,579** stopovers compared to **50,562** during the same time in 2018.



Cumulatively, the Canadian market with **224,425** visitors recorded an increase of **0.8%** or **1,811** less visitors than in 2018. The top producing provinces of Ontario with **156,564** grew by **2.2%**, and those from Quebec, with **27,408** visitors fell by **2.2%**.

Europe

The European market region recorded a decrease of **5.4%** in June 2019, with **22,762** stopover arrivals compared to the **24,073** recorded in June 2018.

In the Northern European region, the main visitor producing countries, United Kingdom, with **17,526** arrivals, grew by **1.0%**, and Ireland with **223** arrivals fell by **23.1%**.

In the South-Western European region, Germany with **1,407** visitor arrivals decreased by **30.3%**, Portugal with **753** fell by **0.9%**, Italy with **656** fell by **29.0%** and the Netherlands with **472** arrivals decreased by **23.5%**.

Stopover arrivals from Central-East Europe with **238** arrivals fell by **49.1%**.

For the summer period, May to June 2019, arrivals from Europe fell by **3.6%**, with **46,294** arrivals compared to **48,046** in 2018.

For the January to June 2019 period, arrivals from the European market region grew by **1.6%**. Total stopover arrivals were **161,120** compared to **158,647** in 2018. Northern Europe rose by **4.7%**, moving from **108,105** in 2018 to **113,137** in 2019.

Arrivals from the South/West region fell by **8.1%**, with **40,292** arrivals, and those from Central/East region increased by **14.6%** with **7,691** arrivals.

Latin America

Arrivals from Latin America decreased by **4.1%** in June 2019, with a total of **2,602** stopovers compared to **2,712** in June 2018.

From the Central American region, stopover arrivals grew by **16.5%** with **910** arrivals. Mexico with **398** arrivals grew by **26.8%**, and Panama with **173** fell by **19.2%**.

From the South American region, stopover arrivals fell by **12.4%** with **1,692** arrivals. Argentina with **360** fell by **13.7%**, Colombia with **320** arrivals decreased by **5.6%**, and Chile with **298** arrivals fell by **40.4%**.

For the summer period, May to June 2019, arrivals from Latin America increased by **26.7%**, with a total of **7,226** arrivals compared to **5,704** in 2018.

Cumulatively, January to June 2019, stopover arrivals from Latin America increased by **12.2%**, with a total of **19,629** arrivals compared to **17,496** in 2018.

Stopovers from Central America with **5,140** arrivals grew by **16.0%**. The main producing countries of Mexico and Panama increased by **13.9%** and **12.1%** respectively.

Stopovers from South America grew by **10.9%** with **14,489** arrivals. The top producing countries of Brazil with **3,297** arrivals grew by **3.6%** Argentina with **3,286** fell by **13.3%**, and Chile with **2,980** grew by **12.4%**.

The Caribbean

Stopover arrivals to Jamaica from the Caribbean region grew by **6.2%** in June 2019 with a total of **6,150** visitors, compared to **5,793** in June 2018.

The Cayman Islands and Trinidad & Tobago continued to be the major visitor producing Caribbean countries in June 2019 with **1,809** and **1,103** stopover arrivals, respectively.

Year to date, stopovers for the January to June period increased by **4.7%** moving up from **30,828** in 2018 to **32,286** in 2019.

Asia

The Asian market fell by **9.3%** in June 2019 with a total of **607** stopovers compared to **669** in June 2018.

China, India, and Japan are the major visitor-producing countries with **279**, **127** and **100** stopovers arriving from each country, respectively.

For the January to June 2019 period, stopover arrivals from Asia grew by **10.9%** with **4,375** arrivals compared to **3,945** in 2018.

Other Countries


Overall, stopover arrivals from other countries grew by **0.9%** with **3,087** arrivals, for the January to June 2019 period. Of the Other Countries, Australia provided the most stop-over arrivals to Jamaica, with **1,115** visitors compared to **1,104** in 2018. This represents an increase of **1.0%**.

Market Share

The market share of stopover visitors for January to June 2019 was as follows: USA **68.0%**; Canada **16.1%**; UK **7.8%**; Continental Europe **3.8%**, the Caribbean **2.3%**; and the others, including Latin America and Asia **1.9%**.

Cruise Passengers

A total of **66,552** cruise passengers visited Jamaica in June 2019. This represented a **27.9%** decrease over the **92,323** who visited in June 2018.



For June 2019, Cruise passengers visiting the port of Ocho Rios fell by **20.7%** with **25,569** passengers, those visiting the port of Falmouth fell by **20.1%** with **23,839** passengers and the Montego Bay port recorded a decline of **42.4%** with **17,144** passengers.

For the first two month of summer, May to June 2019, cruise passengers visiting Jamaica declined by **35.4%**, with **140,232** passengers. Which was **76,872** less passenger than the **217,104** that visited during the same period in 2018.

Year-to-date, January to June 2019 saw **902,088** cruise passenger arrivals visiting our shores, a decline of **12.4%** or **127,793** less cruise passengers.

Length of Stay

The average length of stay of **Foreign National** arrivals in June 2019 was **7.8** nights, compared to **8** nights in June 2018. The average length of stay in hotels was **5.8** nights in June 2019, compared to **5.9** nights in June 2018.

The average length of stay of **Non-Resident Jamaican** arrivals in June 2019 was **18.4** nights compared to **19.0** in June 2018. The average length of stay in hotels in June 2019 was **8** nights, compared to **8.2** nights in June 2018.

During the January to June 2019 period, the average length of stay for Foreign

National arrivals in all types of accommodations was **7.6** nights compared to **7.7** nights in 2018. For the Non-Resident Jamaican arrivals the average length of stay was **15.5** nights compared to **16.3** nights.

Purpose of Visit

During the month of June 2019, **92.7%** or **205,039** of the **221,301** **Foreign Nationals** visited Jamaica for Leisure, **3.1%** were on Business, **3.7%** were on Other purposes of travel and **0.5%** did not state their purpose of travel.

A total of **14,239** or **81.0%** of the **17,587** **Non-Resident Jamaicans** were visiting for Leisure, **3.3%** were on Business, **12.4%** were on Other purposes of travel and **3.3%** failed to provide a reason for travel.

Year-to-date January to June 2019, **90.8%** or a total of **1,262,234** of the total stopover arrivals of **1,390,683** visited Jamaica for Leisure, **3.8%** were on Business, **4.7%** were on Other purposes of travel and **0.7%** did not state their travel purpose.

Intended Resort Area of Stay

Of the **238,888** stopover arrivals visiting Jamaica in June 2019, the resort area of Montego Bay welcomed **89,101** arrivals or **37.3%**; Ocho Rios received **49,686** or **20.8%**, Negril welcomed **45,093** or **18.7%**; and **23,543** or **9.9%** visited Kingston. The remaining **13.2%** stayed in the Mandeville/South Coast, Port Antonio resort regions and Other areas in Jamaica.

Between January to June 2019, the combination of Montego Bay, Negril, and Ocho Rios accounted for **1,091,122** or **78.5%** of the total stopover arrivals.

Type of Airlines used

Of the **1,390,683** stopover visitors to Jamaica in the January to June 2019, **1,283,159** or **92.3%** used scheduled airlines, while **107,524** or **7.7%** used chartered flights.

During the corresponding period in 2018 the percentage distribution was: **92.8%** - used scheduled airlines and **7.2%** - used chartered flights.





STOPOVER ARRIVALS BY PURPOSE OF VISIT JANUARY - JUNE 2019



STOPOVER VISITORS BY MARKET SHARE










