TOURIST (Stopover Arrivals)

Stopover arrivals in March 2020 were 111,191 a decrease of 59.1% or 160,551 less arrivals below the 271,742 recorded in March 2019.

For the January to March period, arrivals decreased by 18.9%, with 574,131 stopovers compared to 708,297 in 2019.

United States

Stopover arrivals from the United States market recorded a decrease of 57.5% in March 2020, with a total of 78,318 arrivals compared to the 184,394 arrivals who visited in March 2019. All the US marketing regions recorded decreases in arrivals, the Northeast with 31,448 declined by 55.2%, the Mid-West with 18,663 declined by 61.2%, the South with 19,337 declined by 59.1%, and the West with 8,870 declined by 52.8%.

For the January to March period, the US market region has declined by 17.4%, with 377,076 in 2020. The Northeast has fallen by 11.2%, the Midwest fell by 22.9%, the South fell by 21.3%, and the West fell by 19.5%.

Canada

In March 2020, the Canadian market recorded a decrease in arrivals of 62.4%, with 18,519 stopovers compared to 49,266 in March 2019.

Stopover arrivals from Atlantic Canada fell by 68.3%; the main provinces of Nova Scotia declined by 65.1%, over March 2019 and those from New Brunswick declined by 57.2%.

Stopover arrivals from Central Canada decreased by 60.5%; the leading province of Ontario declined by 60.2%, while the second most important Canadian province of Quebec declined by 61.5%.

Stopover arrivals from Western Canada fell by 71.6%; the main province of Alberta recorded a decline of 72.7%, while the arrivals from Manitoba declined by 70.3%.

Cumulatively, the Canadian market with 109,355 visitors recorded a decrease of 21.2% or 29,358 less visitors than in 2019. The top producing provinces of Ontario with 75,488 dropped by 20.3%, and those from Quebec, with 15,892 visitors fell by 7.6%.

Europe

The European market region recorded a decrease of 65.1% in March 2020, with 10,162 stopover arrivals compared to the 29,085 recorded in March 2019.


In the Northern European region, the main visitor producing country, United Kingdom, with 7,792 arrivals, fell by 56.4%.

In the South-Western European region, Germany with 807 visitor arrivals declined by 78.1%, France with 294 fell by 65.6%, and the Netherlands with 294 arrivals fell by 60.3%.

Stopover arrivals from Central-East Europe with 192 arrivals fell by 87.4%.

For the January to March 2019 period, arrivals from the European market region fell by 28.4%. Total stopover arrivals were 61,493 compared to 85,859 in 2019. Northern Europe fell by 21.4%, moving from 55,118 in 2019 down to 43,315 in 2020. Arrivals from the South/West region fell by 35.2%, with 15,793 arrivals, and those from Central/East region decreased by 62.5% with 2,385 arrivals.

Latin America

Arrivals from Latin America decreased by 21.9% in March 2020, with a total of 2,077 stopovers compared to 2,659 in March 2019.

From the Central American region, stopover arrivals fell by 58.4% with 368 arrivals. Mexico with 158 arrivals fell by 56.7%, and Panama with 101 fell by 55.5%.

From the South American region, stopover arrivals declined by 3.7% with 1,709 arrivals. Argentina with 741 arrivals grew by 109.9%, Peru with 368 arrivals increased by 139.0%, while Chile with 230 decreased by 37.7%.

Cumulatively, January to March 2020, stopover arrivals from Latin America increased by 35.3%, with a total of 12,643 arrivals compared to 9,344 in 2019.

Stopover arrivals from Central America with 2,009 arrivals fell by 17.1%. The main producing countries of Mexico and Panama decreased by 12.6% and 14.1% respectively.

Stopovers arrivals from South America grew by 53.7% with 10,634 arrivals. The top producing countries of Argentina with 3,700 rose by 123.2%, Chile with 2,383 grew by 33.7%, and Peru with 1,801 arrivals grew by 229.9%.

The Caribbean

Stopover arrivals to Jamaica from the Caribbean region were down **64.5%** in March 2020 with a total of **1,791** visitors, compared to **5,046** in March 2019.

The Cayman Islands and Trinidad & Tobago were the major visitor producing Caribbean countries in March 2020 with **533** and **260** stopover arrivals, respectively.

Year to date, stopovers for the January to March period fell by **19.3%** moving from **13,897** in 2019 to **11,208** in 2020.

Asia

The Asian market fell by **81.9%** in March 2020 with a total of **159** stopovers compared to **880** in March 2019.

Japan and India, are the major visitor-producing countries with **49**, and **52** stopovers arriving from each country, respectively.

For the January to March 2020 period, stopover arrivals from Asia fell by **45.9%** with **1,206** arrivals compared to **2,229** in 2019.

Other Countries


Overall, stopover arrivals from other countries fell by **23.8%** with **1,150** arrivals, for the January to March 2020 period. Of the Other Countries, Australia provided the most stop-over arrivals to Jamaica, with **453** visitors compared to **588** in 2019. This represents a decrease of **23.0%**.

Market

The market share of stopover visitors for the period January to March 2020 was as follows: USA **65.7%**; Canada **19.0%**; UK **7.1%**; Continental Europe **3.7%**, the Caribbean **2.0%**; and the others, including Latin America and Asia **2.6%**.

Cruise Passengers

A total of **66,127** cruise passengers visited Jamaica in March 2020. This represented a **62.7%** decrease over the **177,293** who visited in March 2019.



For March 2020, Cruise passengers visiting the port of Ocho Rios fell by **46.8%** with **31,920** passengers. Those visiting the port of Montego Bay fell by **60.2%** with **21,620** passengers and those visiting the port of Falmouth fell by **81.1%** with **11,883** passengers.

Year-to-date, January to March 2020 saw **449,271** cruise passenger arrivals visiting our shores, a decline of **28.6%** or 179,878 less cruise passengers.

Length of Stay

The average length of stay of **Foreign National** arrivals in March 2020 was **7.2** nights, compared to **7.0** nights in March 2019. The average length of stay in hotels was **5.9** nights in March 2020, which was at the same level of nights in March 2019.

The average length of stay of **Non-Resident Jamaican** arrivals in March 2020 was **16.1** nights compared to **13.4** in March 2019. The average length of stay in hotels in March 2020 was **7.0** nights, compared to **6.7** nights in March 2019.

During the January to March 2019 period, the average length of stay for Foreign National arrivals in all types of accommodations was **7.8** nights compared to **7.7** nights in 2019. For the Non-Resident Jamaican arrivals the average length of stay was **15.6** nights compared to **15.3** nights.

Purpose of Visit

During the month of March 2020, **92.3%** or **96,387** of the **104,454** **Foreign Nationals** visited Jamaica for Leisure, **3.1%** were on Business, **4.1%** were on Other purposes of travel and **0.5%** did not state their purpose of travel.

A total of **5,017** or **74.5%** of the **6,737** **Non-Resident Jamaicans** were visiting for Leisure, **4.6%** were on Business, **17.1%** were on Other purposes of travel and **3.8%** failed to provide a reason for travel.

Year-to-date January to March 2020, **90.2%** or a total of **517,702** of the total stopover arrivals of **574,131** visited Jamaica for Leisure, **3.6%** were on Business, **5.6%** were on Other purposes of travel and **0.6%** did not state their travel purpose.

Intended Resort Area of Stay

Of the **111,191** stopover arrivals visiting Jamaica in March 2020, the resort area of Montego Bay welcomed **41,887** arrivals or **37.7%**; Ocho Rios received **25,984** or **23.4%**, Negril welcomed **21,209** or **19.1%**; and **8,538** or **7.7%** visited Kingston. The remaining **12.2%** stayed in the Mandeville/South Coast, Port Antonio resort regions and Other areas in Jamaica.

Between January to March 2019, the combination of Montego Bay, Negril, and Ocho Rios accounted for **455,598** or **79.4%** of the **574,131** total stopover arrivals.

Type of Airlines used

Of the **574,131** stopover visitors to Jamaica during the period January to March 2020, **538,385** or **93.7%** used scheduled airlines, while **35,745** or **6.2%** used chartered flights.

During the corresponding period in 2019 the percentage distribution was: **91.4%** - used scheduled airlines and **8.6%** - used chartered flights.

STOPOVER ARRIVALS BY PURPOSE OF VISIT JANUARY - MARCH 2020












