Proof of the deliverables below must be submitted:

- In-depth knowledge and track record in branding of different publicity materials
- Portfolio of major assignments effected in the past two (2) to four (4) years relating to the scope of the project
- Reference of past customers showcasing the promotional "giveaway" items provided in the past three (3) years
- Demonstrate a variety of marketing items and design services through product catalogue such as hats, caps, bags, towels, etc.
- Provide actual sample of the core items. Sample will serve as quality reference for products that will be produced under the contract.
